### I. Scoring Framework

Hospitals that have been accepted into the Hospital Transformation Program (HTP) must submit an Implementation Plan detailing the strategies and steps they intend to take in implementing each of the interventions outlined in their approved HTP applications.

Implementation Plans collect the hospital approach on the Organizational Approach to Implementation and the Approach to Intervention Implementation. The Approach to Intervention Implementation must be completed for each of the hospital's interventions. Except for questions that are prepopulated from the Hospital Application, responses will be scored on either a pass / fail or a numerical basis as outlined below.

Pass / fail scores will be based on the following:

- Fail: The response is incomplete because it does not address one or more parts of the question asked. More information must be provided for the answer to be considered complete.
- Pass: A complete response was provided to all applicable aspects of the question.

Implementation Plans must earn passing scores for every pass / fail response to be approved. Any question receiving a failing score during the review period will be returned to the participant with specific instructions for revisions prior to resubmission.

Numerical scores will be based on a one to three (1 - 3) scoring rubric.

- A score of one (1) will be given to answers that need substantial revision. Scores of one indicate that responses are either incomplete (do not address one or more part(s) of the question asked) or do not demonstrate a satisfactory approach. Examples of responses that would not demonstrate a satisfactory approach include:
  - ✓ A response to Question III.A.6. that does not include a plan for identifying and engaging the intervention's target population including addressing barriers to recruitment and resulting gaps in engagement.
  - A response to Question III.A.7. that does not describe the resources that will need to be re-purposed from other areas, built, acquired, or secured through a partner or in some way.

- ✓ A response that describes supporting documentation for an impact milestone that is insufficient to validate its completion.
- A score of two (2) represents a generally complete and satisfactory response to the question (criteria for scores of one outlined above do not apply) with only limited clarification or additional information needed to ensure responses are detailed enough to provide the Department with a complete and accurate understanding of the response. Any additional information or clarification needed will be specifically cited by the Department.
- A score of three (3) represents a complete, sufficiently detailed and acceptable response and approach to the topic addressed (criteria for scores of one and two outlined above do not apply).

Participants must earn scores of three (3) for every response included in their Implementation Plan for it to be approved. Any question receiving a one (1) or two (2) during the initial Implementation Plan review period will be returned to the hospital with specific instructions for revision prior to resubmission. The Department will provide technical assistance aimed at ensuring Implementation Plans receive approval.

The tables below summarize the questions in the Implementation Plan and the applicable scoring. Questions that will be prepopulated in the Implementation Plan submission tool from the Hospital Application will not be scored and are marked as "prepopulated" in the scoring column of the tables below.

- An overall score will be assigned for Question III.A.6., which encompasses the responses to Question III.A.6.a. and Question III.A.6.b.
- Responses will be reviewed for completeness and approach.
  - ✓ Does the response include a brief description of the intervention's target population?
  - ✓ Does the target population align with the measure(s) selected?

**Question III.A.6.b.** Describe how individuals within the target population will be identified and engaged in the intervention. (Please seek to limit response to 500 words.)

- Numerical score (1-3)
- Responses will be reviewed for completeness and approach. (Part of overall score for Question III.A.6.)
  - Does the response demonstrate how individuals within this population will be identified?
  - ✓ Does the response describe how individuals within the target population will be engaged by involving them in their healthcare?
  - ✓ For engagement of the target population, consideration will be given to the type of intervention, and patient engagement may be active during care or through delivering information / education.

  - ✓ Do the responses to Questions III.A.8.b. and III.A.8.c. specifically address challenges and risks the following areas? (It is not required that challenges / risks are identified in all areas.)
    - Workforce;
    - Budget;
    - Health Information Technology;
    - Regulatory Barriers; and
    - Challenges related to engaging difficult-to-reach populations.

**Question III.A.8.b.** Use the following space to describe any major challenges and risks to intervention implementation. (Please seek to limit response to 750 words.)

- Responses will be reviewed for completeness. (Part of overall score for Question III.A.8.)
  - ✓ Does the response describe major challenges and risks to intervention implementation in one or more of the areas listed?

**Question III.A.8.c.** Use the following space to describe how the hospital will mitigate the challenges and risks described above. (Please seek to limit response to 750 words.)

- Responses will be reviewed for completeness and approach. (Part of overall score for Question III.A.8.)
  - ✓ Given the challenges and risks that exist, does the response describe how the hospital will mitigate the impact on the success of the intervention?

**Question III.A.9**. Describe how this intervention will benefit from the hospital's ongoing Community and Health Neighborhood Engagement efforts. (Please seek to limit response to 500 words.)

- Pass / Fail score
- Responses will be reviewed for completeness.
  - ✓ Does the response describe how the hospital will use Community and Health Neighborhood Engagement (CHNE) as a learning opportunity and explain how the intervention will benefit from and be supported by the ongoing CHNE efforts?

#### **B.** Intervention Milestones

Hospitals must propose and record in the Implementation Plan submission tool one milestone in both Quarters 2 and 4 (Q2 and Q4) for each Program Year (PY) starting with PY2Q2 (Jan. - Mar. 2023). Milestones should be discrete tasks that, when completed, have an easily identifiable, quantifiable, and definable goal that has been reached or action that has been completed.

The Implementation Plan submission tool will guide hospitals through the process of establishing milestones as applicable for each intervention for the duration of the HTP. Important information on HTP requirements associated with intervention milestones can be found in the *HTP Implementation Plan Template and Milestone Requirements* located <u>here</u>. This includes specific milestone elements for certain measures.

Questions III.B.1., III.B.2., and III.B.3.

- An overall numeric score (1-3) will be assigned to each milestone proposed by the hospital, based on the responses to questions III.B.1., III.B.2., and III.B.3.
- Responses to Questions III.B.1., III.B.2., and III.B.3. will be provided for each milestone.
- Depending on the phase of the intervention, Question III.B.3. may contain up to three parts: III.B.3.a., III.B.3.b., III.B.3.c.
- Responses will be reviewed for completeness, approach, and adherence to applicable program requirements (as outlined in the *HTP Implementation Plan Template and Milestone Requirements* located <u>here</u>).

Question III.B.1. What phase does this milestone fall under?

- Hospital Index: The final Planning and Implementation milestone (impact milestone) must be completed PY2Q2 (January-March 2022). This means that the milestones must begin the Continuous Improvement phase with the PY2Q4 (July-September 2023) milestone.
- Existing Interventions: The final Planning and Implementation milestone (impact milestone) must be completed no later than the PY3Q2 (January-March 2023) milestone. This means that milestones must begin the Continuous Improvement phase no later than the PY3Q4 (July-September 2024) milestone.
- New Interventions: The final Planning and Implementation milestone (impact milestone) must be completed no later than the PY3Q4 (July-September 2024) milestone. This means that milestones must begin the Continuous Improvement phase no later than the PY4Q2 (January-March 2025) milestone.
- Responses will be reviewed for completeness and adherence to applicable program requirements.
  - ✓ Was a response provided?
  - ✓ Does the response reflect an acceptable phase given the following factors?
    - The quarter of the program the milestone relates to
    - Whether the intervention is new or existing
    - The measure(s) that the intervention will address

- Impact milestones must include all Functional Areas.
- The impact milestone can reference prior quarters for activities already completed and provide a narrative update rather than repeating the same information. In this case, the hospital should describe how the functional process has been operationalized and is being maintained.
- Responses will be reviewed for completeness and adherence to applicable program requirements.
  - ✓ This question is applicable to "Planning and Implementation" phase milestones only, which requires the selection of a functional area(s).
  - ✓ Was a response provided?
  - ✓ If this is an impact milestone, were all functional areas selected?

**Question III.B.3.b.** This question is phrased one of two ways, depending on whether the milestone is in the "Planning and Implementation" or "Continuous Improvement" phase.

**Planning and Implementation**: Please include a brief description of the applicable [*People, Process, Technology, Patent Engagement / Target Population*] Functional Area(s) for this milestone (no more than two sentences per functional area).

**Continuous Improvement:** Please include a brief description of the milestone (no more than two sentences).

- Responses will be reviewed for completeness, approach, and adherence to applicable program requirements.
  - ✓ Does the response contain a short description of the actions that will constitute completion of the milestone?
  - ✓ Is the milestone sufficiently concrete that the hospital can identify whether the milestone was completed and provide documentation to verify completion?
  - Does the milestone specified correspond to the "Planning and Implementation" or "Continuous Improvement" phase selected in Question III.B.1.?
  - ✓ If a "Planning and Implementation" phase milestone, is the activity relevant to the functional area selected in Question III.B.3.a.?
  - ✓ If an "Impact Milestone" was selected in Question III.B.2., does the milestone address all functional areas, and does the milestone demonstrate completion of the "Planning and Implementation" phase?

- Responses will be reviewed for completeness, approach, and adherence to applicable program requirements.
  - ✓ Does the response contain a short description of the supporting documentation that will be provided in support of the milestone's completion?
  - ✓ Does the response state explicitly and unambiguously what piece(s) of documentation will be provided? (Note: Statements that "evidence will be provided", or "documentation will be furnished" to support milestone completion are typically not concrete enough to meet this requirement.)
  - ✓ Is the documentation sufficient to verify or prove milestone completion?
  - ✓ If the milestone contains multiple elements, does the documentation allow verification of each element's completion?
