# HRC Stakeholder Engagement Workgroups

The Department reviewed the suggestions from the stakeholder groups to determine any changes and/or next steps.

- Clarification
  - Statute limits the HRC to I/DD Waivers only.
  - Final Settings Rule for informed consent applies to all waivers.
- Department is trying to determine how to streamline processes for all CMA's
