APR-DRG

Inpatient hospital services claims with discharge date on or after October 1, 2015	Reimbursed using All-Patient Refined (APR-DRG) grouper version 33.0
Discharge Date	Grouper
October 1, 2015 - Current	APR- DRG Version 33
January 1, 2014 - September 30, 2015	APR- DRG Version 32
October 1, 2006 - December 31, 2013	Version 24.0 + annual crosswalks
October 1, 2005 - September 30, 2006	Version 23.0
October 1, 2004 - September 30, 2005	Version 22.0
October 1, 2003 - September 30, 2004	Version 21.0
October 1, 2002 - September 30, 2003	Version 20.0

APR-DRG

- The Department updated the payment methodology to APR-DRG Version 33 as of July 1, 2016
 - All claims with discharge dates on or after October 1, 2015, will process payment through Version 33
 - ➤ The Department will reprocess claims that have already been submitted with discharge dates on or after October 1, 2015 to utilize APR-DRG Version 33
- The differences between APR-DRG Version 32 and 33 are minimal and will not likely impact many claims

Inpatient Pricing

Transfer Payment Logic:

- > IF Covered Days < DRG Average Length of Stay, THEN pay Per Diem * Covered Days
- > IF Covered Days >= DRG Average Length of Stay, THEN pay DRG Base Payment

Per Diem Calculation:

- Per Diem = DRG Base Payment/DRG Average Length of Stay
- Outlier Payment Logic:
 - Outlier Days = Covered Days beyond DRG Trim Point
 - Outlier Payment = Outlier Days * Per Diem * 80%

Outpatient Pricing

- Before October 30, 2016 Reimbursement for outpatient hospital services was calculated using a cost to charge ratio and cost settlements based on Medicare's audited cost report
- As of October 31, 2016 Reimbursement is calculated using Enhanced Ambulatory Payment Grouper Systems (EAPGS)

Payments for outpatient services are based on the following formula: EAPG Adjusted Weight * Hospital Medicaid Outpatient Base Rate

Due to EAPG pricing mechanisms (Discounting, Packaging, Consolidation), items will not always pay based on the EAPG weight schedule posted to the <u>Outpatient Hospital Payment page</u>. The payment formula utilizes the adjusted weight rather than the posted EAPG weights.
