MINUTES OF THE WEBEX INTEGRATED QUALITY IMPROVEMENT COMMITTEE (IQuIC) MEETING

4. Network Adequacy Validation (NAV) Tableau Overview

Alana Berrett (Health Services Advisory Group/HSAG), Ashling Whelan (HSAG) and Rachel Perry (HSAG) led this PowerPoint (PP) presentation. Discussion focused on the following PP slides: Presentation Overview, What is the Member and Network Data Quality File Review, Quarterly Data Quality File Review Process, Accessing the Dashboard in Tableau, Data Quality Dashboard Landing Page, Demonstration of Member and Network Data Quality Review Dashboards, Accessing the Data Quality Review Dashboards, Dashboard External User Registration Form, MCE's Quarterly Responsibilities, Anticipated Communication Process, Key Milestones..., and General Comments and Questions. Meeting attendees asked the HSAG presenters questions about accessing the dashboard for numerous lines of business and the number of sign in accesses will be allowed.
