# 2. Purpose and Scope of Collaboration Agreements

The purpose of these agreements is to facilitate <u>timely enrollment of Medical Assistance</u> <u>applicants</u>, <u>ensure coordination between entities for ongoing eligibility and case</u> <u>maintenance</u>, provide for <u>potential on-site stationing of County Department personnel</u>, and to provide opportunities for external entity cost sharing between the State and County Departments, the federal government and the external entities.

a. To ensure applicants who are hospitalized have access to timely determinations for discharge, the County Department shall enter into formal agreement(s) with the external entities that are within the county's boundaries by January 1, 2026. This agreement can be between the individual external entities and the County Department or a single agreement across multiple external entities and the County Department, if the county's boundaries contain more than external entity. The agreements shall contain the Medical Assistance minimum requirements listed below

- What we can expect at the moment
  - Counties provide signed contract/agreement with new and existing hospital(s)
  - Three types of agreements (next slide)
  - Contract/agreements requirements could change in the next few months while Hospital Taskgroup works through details
  - The incentive contracts/agreements or Internal control will have a centralized performance metric tracking tool to submit monthly data.
    - Develop Performance metrics with ITG for each type of agreement

- What we can expect at the moment
  - Hospital Task Force (Three Agreements)
    - Eligibility & Enrollment Collaboration Agreement: a non-cost sharing agreement that facilitates collaboration between providers and county
    - Eligibility & Enrollment Collaboration Agreement with Cost Sharing: an agreement that facilitates onsite placement of county staff in provider settings, with state and county costs covered by the provider
    - MOUs between counties, served by the same hospital/provider, that allow for one county to take the lead for onsite placement of staff; eligibility determinations for all counties in the MOU will be completed by the lead county

- Things to come
  - Clarify the Nursing facility (NF) and Case
     Management Agency(CMA) is not an agreement
     but internal process control.
  - Can multiple counties can be a part of one agreement (formalize MOU)?
  - When will the deliverable be due for the incentive contract?
  - How will Counties submit the deliverable to HCPF?
