

## Participant-Directed Programs Policy Collaborative Attendance and Voting Rights Information

The following document shows Participant-Directed Programs Policy Collaborative (PDPPC) voting rights as of the month named at the top of the chart. The ability to vote in the PDPPC is based on consistent stakeholder participation. Stakeholders in defined categories who have attended three meetings in a row are given voting rights. An individual carrying the vote for their organization must meet this attendance requirement. Three consecutive unexcused absences will result in the loss of a vote.
