I am pleased to submit the Department of Health Care Policy and Financing (HCPF)'s 2023 Regulatory Agenda Report and 2024 Regulatory Agenda, in compliance with 2-7-203 C.R.S., as amended by House Bill 12-1008. The Department's 2024 Regulatory Agenda has also been submitted to the Colorado Secretary of State for publication in the Colorado Register, and will be posted to our website.
