

NCCI Professional Claims Automated Audit: Wheelchair Benefit Coverage



Audit updated to exclude audit findings for allowable wheelchair backups & accessories

NCCI Professional Claims Automated Audit: Incontinence Supplies

Inpatient Complex Audits



Inpatient audit initial demands/notices have been paused

What Providers can expect:

- Informal Reconsideration have a statute timeline we cannot halt
 - 30 days to request
 - 45 days for HCPF/HMS response
- Appeals have a statute timeline we cannot halt
 - 30 days to file a formal appeal with the Office of Administrative Courts (OAC)
- Record requests and exit conferences will continue



Temporary Inpatient Audit Pause

These changes are designed to:

- Preserve your (provider) rights to informal reconsideration and formal appeal
- Preserve the state's responsibilities for oversight of improper payments to the Federal government
 - Improper payment measurements:
 - When we (HCPF CO State) are above the 3% Federally mandated threshold in statute from all areas of Medicaid, this can result in general funds being used to repay the federal government for improper payments
 - Nationally Medicaid has an improper payment rate of 24%
 - Colorado Medicaid has an 12% we are doing better than most, but general funds are at risk that could be use for other areas (rates/increased benefits)
 - The RAC is meant to identify improper payments, lessening or eliminating the decrease in general funds
 - All RAC recoveries are returned to the general medical services line
 - This increases access to care through better payments for benefits to providers or more broad coverage, because we can afford to offer those benefits

Overall, this means more funds for benefit coverage for rates, behavioral health, autism support, and in general it is a healthier Colorado overall

Inpatient Rebilling Updates

- We have found a semi-automated process to re-bill, however, we are still testing the system with a smaller population of providers
- Inpatient audits are paused in part to update notices with the re-billing option, the process, and to create training around this change
- Once notices (letters) are updated and rebilling is in place the inpatient initial demands/notices will be resumed

Thank you for your patience while we reprogram the claims system, listen to participants in the pilot, formalize the instructions and quick guides.

The ultimate goal is to have safe guards in place and reporting. We also need to have a formal process everyone understands prior to initiating changes.

Understanding Rebilling Inpatient Claims

Inpatient Audits are Not just Inpatient vs. Outpatient

Colorado Complex Inpatient RAC Audits currently include 60+ findings which are reviewed by both RNs (Master RN Degrees, pediatric, trauma, and psych specialties +) & MDs in multi levels, and are not solely software driven audits. These audits include medical billing errors including many repriced or full takebacks based on:

- Cancelled Surgery (no services for inpatient procedures were ever rendered)
- DRG coding errors (primary diagnosis DRG upcoding errors)
- Outpatient orders that superseded inpatient orders (no inpatient services rendered, no federally required inpatient order)
- Clinical validation (secondary and tertiary diagnosis codes - DRG upcoding errors)
- Technical denials No records were ever given
- Incomplete records (nurse records are so important)

Accreditations for a RAC (Program Integrity) Vendor

URAC accreditation is standard & our vendor maintains this credential which requires staffing of highly qualified staff
