MPRRAC History

- Originally created from <u>SB15-228</u> and amended by <u>SB22-236</u>
- Committee size reduced from 24 members to 7
- Reduced from 5-year cycle to 3-year cycle
- Past Outcomes
 - Reduced anesthesia rates to 100% of Medicare
 - Increased UPL rates over 100% of Medicare in effort to pay for high values services
 - Rebalanced all services under review to ensure outliers are within a reasonable variance from the benchmark



Lessons Learned

- Preparation matters
- Expand provider participation
- Ensure time for conversation
- Encourage "self-governing" of the committee
- Pursue collaboration
