#### **NF Enterprise Board**

- SB 25-270 Governor appointing members to Facility Provider Fee Enterprise Support Board
- Board Overview
  - The Facility Provider Fee Enterprise Support Board is responsible for:
  - Advising on the structure, calculation, and implementation of provider fees
  - Recommending changes that improve fee distribution equity
  - Supporting rulemaking related to supplemental Medicaid payments and reimbursements
  - Establishing reporting requirements for facilities
- Members Needed:
  - Two representatives from nursing facility associations
  - Two representatives from nursing facilities (one from a rural facility)
  - One resident or consumer of long-term care services (or a family member/guardian)

- Current Topic- potential new measure
  - □ Nutrition/Palatability/Dining re-work
  - □ Workplace Violence/Staff Safety



#### P4P Timeline Changes

- HCPF is changing the portal opening date to January 1 (from December 1) to allow additional development time.
  - Data shows minimal activity in December
  - Application is available for prep work.
- Appeal timeframe will be reduced to 2 weeks.
  - □ May 15th rather than May 30th.



#### **CMS-Nursing Home Staffing**

- CMS has announced intent to allow CMP funds for staffing recruitment efforts.
  - □ Tuition reimbursement for nurses.
  - Stipends for new workforce.
- Details are still pending as is the process for submitting a plan.

#### CMS-Nursing Home Staffing cont.

- CMS has announced intent to allow CMP funds for staffing recruitment efforts.
  - □ Tuition reimbursement for nurses.
  - Stipends for new workforce.
- Details are still pending as is the process for submitting a plan.

#### **Special Session Budgetary Reduction**

- NF Minimum Wage payment was identified as a budget reduction item for the current year.
  - □ Payment will not go out in the spring.
  - □ Minimum wage is \$14.81/hr. in 2025
    - This payment was intended to supplement up to \$15/hr.



## **Audited Financials**

- HB 23-1228 added requirements for audited financial statements
- Effective date was attached to the most recent Cost Report (SFY 2024-2025 filings)

## Audited Financials cont.

- Financial Transparency Regulations are found at 10 CCR 2505-10 Section 8.450
- Regulation allows for reviewed financial statements in 1st year
- Also allows for waivers and/or timeliness adjustments

### **Audited Financials - Action Needed**

• Sub-50% compliance rates currently

#### **Action Needed:**

 Organizations or facilities must submit either a waiver request, expected timeline for submission or financial statements ASAP if they have not already done so.
