National Core Indicator- Intellectual and Developmental Disabilities (NCI-IDD)

National Core Indicators (NCI) is a collaborative effort between the National Association of State Directors of Developmental Disabilities Services (NASDDDS), the Human Services Research Institute (HSRI), and participating states, using standard measures to track and assess the outcomes of programs and services provided to individuals and families. Efforts to analyze the multi-state datasets have been supported by the Centers for Medicare and Medicaid Services (CMS), the Administration on Intellectual and Developmental Disabilities (AIDD), and the National Institute on Disability and Rehabilitation Research (NIDRR). Results of these analyses have been published in both national and international peer-reviewed journals and presented at research conferences around the world.

The National Core Indicators - Intellectual and Development Disabilities Survey (NCI-IDD) (also known as the In-Person Survey or IPS) is typically a face-to-face conversation completed with a minimum of 400 individuals who are 18 years of age or older, diagnosed with an Intellectual or Developmental Disability, and receiving at least one paid service from the state, in addition to case management. Colorado's current sample has included adults enrolled on the Developmental Disabilities (DD) or Supported Living Services Waiver (SLS) waivers, targeting participation in specific services provided by each waiver. The intent of the survey is to understand demographics and address key areas of concern such as employment, respect/rights, service planning, community inclusion, choice, and health and safety. The data that result from NCI surveys are often used to inform strategic planning, produce legislative reports, and prioritize quality improvement initiatives, and to also share the data with stakeholder groups and use the stakeholder feedback to help set priorities and establish policy direction.

Before the survey, Background Information is collected using administrative records, and often additional information is collected from service coordinators/case managers. Background Information includes data such as demographics, personal characteristics, health data and data on employment status and wages.

The face-to face portion of the NCI-IDD is conducted in person or via video conferencing, with the person receiving services; Section I can only be answered by the individual. No proxy responses are permitted. Section II may be completed by a proxy if the interviewer determines the individual receiving services cannot answer for him or herself. NCI-IDD aims to increase the reliability of proxy responses by allowing only those people who know the individual well (family, friends, staff, etc.) to serve as proxy respondents.

Evolving the In-Person Survey (NCI-IDD) in Colorado

Colorado has been participating in the NCI-IDD annually since 2013. Starting the survey cycle of 2022-2023, Colorado began to alternate participation survey cycle years between the NCI-IDD and the National Core Indicators-Aging and Disabilities (NCI-AD) survey. Alternating years between the two surveys will allow Colorado to increase the survey completion target from around 400 responses to about 1,200 responses per survey cycle. The alternation began with NCI-AD in 2022-23 and the NCI-IDD will launch in the new cycle in FY 2023-2024.

How are data shown in this report?

This report includes Colorado's In-Person Survey data collected between 2016 and 2021, compared to the weighted NCI Average collected during the 2020-21 survey cycle. The weighted NCI average from FY 2020-2021 is labeled as "2020-Weighted NCI-IDD Average." Colorado's NCI data is shown in the below tables as 2016, 2017, 2018, 2019, and 2020, however, data collection begins in July and ends in April or May of the following year. The survey years are represented as follow:

Many questions in the NCI-IDD allow respondents to answer a question with "middle" response like "maybe," "sometimes" or "in-between." The data in this report are "collapsed" data provided by HSRI and NASDDDS. That means that two or more response options are grouped together if they are considered to reflect a positive outcome. To see the breakout of responses for each option, please see Appendix C of the National In-Person Report for the corresponding survey year.

Colorado outcomes that were found to be statistically significantly higher or lower than the NCI-IDD Average by HSRI and NASDDDS, are indicated with an arrow (*the outcomes presented in the report are only for FY 2020-21*):

1. Outcomes where the state is significantly above the NCI-IDD average are denoted with an up arrow \blacktriangle ;

2. Outcomes where the state is significantly below the NCI-IDD average are denoted with a down arrow $\mathbf{\nabla}$.

Note on Impact of COVID-19

It is important to note that data may have been impacted due to the COVID-19 pandemic. In 2019-20, NCI-IDD survey data collection period was unexpectedly abbreviated. National Core Indicators recommended states pause in-person surveying on March 16, 2020, and the NCI-IDD surveying ended in April due to the ongoing pandemic. The 2020-21 NCI-IDD was conducted remotely with the person receiving services and/or their proxy via Zoom video.



NCI Data Report Overview

Notable improvements for Colorado include:

- In 2020-21, 74% of respondents reported they had input in choosing where they live if they do not live in their family home. Colorado has seen a 16% increase since 2016 and scored 18% higher than the NCI weighted average in 2020-21.
- Based on the average hourly wage at a paid community job by type of community employment, Colorado has seen an hourly wage increase since 2016, for individuals with publicly funded supports, individuals with group jobs, and individuals that work at businesses that primary hires people with disabilities. In all three categories, individuals also get paid higher than NCI's weighted average.
- In 2020-21, 78% of respondents reported they went out shopping at least once in the past month. This is a decrease from the previous year, but Colorado scored significantly above the weighted NCI Average. In addition, Colorado has increased in this area from 40% in 2016, to 78% in 2020. In 2020-21, 50% of respondents reported they would like to go out shopping more than they did in the previous month.
- In 2020-21, 85% of respondents reported they can go on a date, are married, or living with partner. Colorado scored significantly above the weighted NCI average, and this is a 28% increase since 2016.
- Colorado continues to score high and/or score significantly above the weighted NCI average in Service Coordination. From 2016 to 2020, an average of 93% of respondents reported have met or spoken with case manager/service coordinator, 89% reported case manager/service coordinator asks person what s/he wants, and 88% reported they know who to ask if s/he wants to change something about services. In addition, on average 96% reported they took part in the last service planning meeting, or had the opportunity but chose not to, and 94% reported their last service planning meeting included people person wanted to be there.
- In the area of Rights and Respect, Colorado has seen an increase in respondents having a key to the home from 44% in 2016, to 66% in 2020. There has also been an increase in respondents having the ability to lock their bedroom if they want to from 36% in 2016, to 62% in 2020.
- In the past five years, the use of nicotine or tobacco products by members has been reduced by half. In 2016, 12% of members reported the use of nicotine or tobacco products, and in 2020, only 6% reported the use.



Areas for improvement in Colorado include:

- In 2020-21, 33% of respondents report they do not get a choice in their roommate if they do not live in their family home or live alone. However, Colorado has seen an increase of 15% since 2016 and scored 22% higher than the NCI average for having a choice with their roommate.
- Since 2016, there has been a 22% increase in respondents reporting they do not have a community job but would like a job in the community. In 2020-21, 56% of respondents reported they do not have a community job and would like a job in the community. In addition, 25% of respondents reported needing additional services in the form of more education or training, and 20% reported the need of assistance finding, maintaining, or changing jobs. However, only 32% of respondents had community employment as a goal in their service plan.
- In 2020-21, 60% of respondents reported they get to do things they like to do in the community as much as they want. Colorado scored significantly lower than the weighted NCI average. While COVID-19 could be part of the reason for the decrease in satisfaction with community access in 2020, Colorado has been seeing a decrease in this area since 2017. In 2020-21, 72% of respondents said they would like to go out for entertainment more, 65% of respondents said they would like to go out to coffee shops or restaurants more, and 56% of respondents reported attending a self-advocacy group, meeting, conference, or event or had the opportunity and chose not to, and only 53% reported voting in local, state, or federal election, or had the opportunity and chose not to.
- Colorado fluctuates from year to year on whether respondents have friends and are able to see their friends when they would like to. In 2020-21, 66% reported they are not able to see their friends when they would like to, with the top reasons being lack of transportation and/or lack of time. On a similar note, 24% of respondents reported needing additional services to address social or relationship issues or meeting people, and 23% reported needing additional services in the form of transportation.
