1. Call to Order, Roll Call, and Meeting Overview

Eloiss Hulsbrink, Rate Review Stakeholder Relations Specialist, called the meeting to order at 9:05 a.m.

There were sufficient members for a quorum with ten members participating. All individuals participated remotely, due to ongoing health and safety requirements regarding the COVID-19 pandemic.

2. Meeting Minutes

MPRRAC members discussed and voted on meeting minutes from the June 25, 2021 MPRRAC meeting. The MPRRAC voted to approve the meeting minutes. Additionally, MPRRAC members discussed and voted on meeting minutes from the September 24, 2021 MPRRAC meeting. The vote to approve the meeting minutes was unsuccessful. Committee members noted that the minutes did not reflect conversation around benchmark methodology and did not use robust terminology when discussing the services in review and therefore did not approve the minutes. Feedback was taken back

by the department and amendments were made, resulting in a rediscussion and vote of the September meeting minutes during the next MPRRAC meeting.

3. 2021 Medicaid Provider Rate Review Recommendation Report

The committee discussed the Department's Medicaid Provider Rate Review Recommendation Report, which was submitted to the Joint Budget Committee (JBC) in November 2021.

The Department received stakeholder comments which disagreed with the Emergency Medical Transportation (EMT) conclusion that 40.92% of the benchmark is sufficient for provider retention and member access because of inaccurate data. The stakeholder was in agreement with the Department's recommendation of increasing the rate for EMT to 80% of the benchmark. Feedback was taken back by the Department and the Department will have a response regarding these comments at the next public meeting.

The committee discussed the timeline of the recommendation report with an emphasis on the process the report goes through, and frustration about the report's submission to the JBC before the Medicaid Provider Rate Review Advisory Committee (MPRRAC) was able to discuss it was noted. Committee Members expressed concern about their lack of inclusion and role in the process. Departmental leadership clarified that the recommendations are shown to the committee beforehand and committee discussion and stakeholder feedback from the September 24, 2021 meeting are incorporated into the final recommendation report. Feedback from committee members about how the MPRRAC process can be improved was taken back by the Department and will be integrated and discussed during the next meeting.

4. Introduction to Year Two (Cycle Two) Service Groupings

The Department provided an overview of Year One (Cycle 2) services, including the data methodology and validation processes.

Additional updates to the presented population pyramids were requested concerning the scales for the X-axes. The Department noted this request.

6. Medicaid Provider Rate Review Advisory Committee (MPRRAC) Vice Chair

The newly appointed MPRRAC chair, Dixie Milton, was unable to attend the meeting, so the previous MPRRAC chair, Tim Dienst, served as acting chair throughout the meeting and opened nominations for the MPRRAC vice-chair. Tim Dienst nominated Christi Mecillas, who was not on the call at the time of the nomination, for the MPRRAC vice-chair. The motion did not pass due to some members abstaining from voting due to the uncertainty of Mecillas' interest. Eloiss will reach out to Mecillas after the meeting to gauge interest. Nominations and voting will continue to the next meeting.

7. Next Steps and Announcements

The Department outlined the next steps for Cycle Two, Year Two rate comparison, and access to care analysis work, including previous year access visuals to prepare new and returning committee members on what type of data to expect in the next meeting and report.

The Department confirmed the date for the next quarterly meeting, to be held on Friday, February 25, 2022, and discussed the primary purpose of the meeting.
