## **Approval of Minutes**

Mr. Pump moved for the approval of the September minutes. The motion was seconded by Dr. Mulkey. The minutes were approved, 7:0.

# A. Emergency Adoption

Document 09, MSB 25-09-04-A, Creation of the Medical Assistance Act Rule Concerning Pediatric Behavioral Therapy, Section 8.281 was pulled from the agenda.

# Amanda Jichlinski joined - 9:26

Document 08, MSB 25-08-26-A, Revision to the Medical Assistance Act Rule concerning Definitive Drug Testing, Section 8.660

Sarah Kaslow, Health Policy Office, presented the rule and explained costs are rising in the program. Provided examples of Presumptive tests v Definitive tests and reviewed increasing costs.

Board Discussion – Board discussion included why this is an emergency now if it has risen over last 10 years, the budget crisis creates the emergency action needed. The Board appreciates cost savings, discussion and staff coming back to the Board at the time of resolution. The rule should go farther and reduce definitive drug tests to 12 annually. Primary Care can be hamstrung if ratcheted down too tight though.

Dr. Kinnard moved for the emergency adoption of Document 08. Dr. Mulkey seconded the motion.

The Board voted on the emergency adoption of Document 08, 8:0.

Document 10, MSB 25-07-24-A, Creation Medical Assistance Act Rule concerning the Provider Stabilization Fund Program, Section 8.970

Tracy Gonzales, Special Financing Division, presented the rule and explained SB 25-290 created the Provider Stabilization fund. Eligible Safety Net providers to receive stabilization funds. Reviewed eligible patients.

Board Discussion – Board discussion included a review of the definition of primary care in the rule – consultation with Board and primary care fund. Perhaps aligning across rules for definition. The definition is aligned with the State definition. Essential providers are captured in HealthCare Provider.

Document 04, MSB 25-07-08-A, Revision to the Hospital Discounted Care Rule Concerning Presumptive Eligibility per SB 24-116

Taryn Graf, Special Financing Division, presented the rule and provided a background of Hospital Discounted Care. Reviewed changes from last month from consultation with stakeholders.

The Board voted the final adoption of Document 04, 8:0.

Document 05, MSB 25-05-30-A, Revision to the Medical Assistance Act Rule Concerning Updates to the Continuous Eligibility Medical Assistance Programs for Children under the age of 19 for Sections 8.100.3.Q.2.d

Melissa Escamilla, Eligibility Policy, presented the rule and explained the rule amends continuous eligibility to 12 months. Reviewed exceptions to the program. Updates to be in compliance with Federal guidance.

Board Discussion – Board discussion included a conversation about spending more trying to collect premiums versus what we is collected, collect more than trying on monthly premiums. Individuals not paying premiums are not sent to collections.

Dr. Mulkey moved for the final adoption of Document 05. Dr. Martin seconded the motion.

The Board voted the final adoption of Document 05, 8:0.

Document 06, MSB 25-07-01-C, Revision to the Medical Assistance Act Rule Concerning Presumptive Eligibility by Qualified Hospitals, Sections 8.100.1, 8.100.3.R & 8.100.4.F

Daisy Martinez, Eligibility Policy, presented the rule and explained a review of the federal rules behind the Medicaid program for presumptive eligibility. Reviewed current state of presumptive eligibility and reviewed proposed changes to align with federal guidance.

Board Discussion – Board discussion included how 33% of members on presumptive eligibility. Require a 95% accuracy rate. Hospitals can see that presumptive eligibility was granted in last 12 months in the system.

Dr. Littler moved for the final adoption of Document 06. Dr. Mulkey seconded the motion.

The Board voted the final adoption of Document 06, 8:0.

Document 07, CHP 25-07-01-D, Revision to the Medical Assistance Act Rule Concerning Presumptive Eligibility by Qualified Hospitals, Sections 50 & 170 Daisy Martinez, Eligibility Policy, presented the rule. Document 07 & 08 presentations combined.
