OCL General Updates

Case Management Verbal Signatures

[Operational Memo 21-070](#)

- Verbal, digital, and physical signatures are allowed on forms used by case managers during the Public Health Emergency.
 - This authorization is applicable for signatures provided by a member, member legal representative, and service providers.
 - This change is **not applicable** to signatures provided by a **medical professional**.
- Authorization is approved back to March 11, 2020. Case Managers are to follow instructions as outlined in [Operational Memo](#)

New Federal Provider Relief Funding

- \$25.5 billion for health care providers affected by the pandemic
 - \$17 billion for Provider Relief Fund Phase 4
 - \$8.5 billion for ARPA Rural funding (seperate from HCBS ARPA funds discussed earlier)
- Application period started 9/29/21
 - ***Deadline 10/26/21 @ 9:59 p.m. Mountain Time***



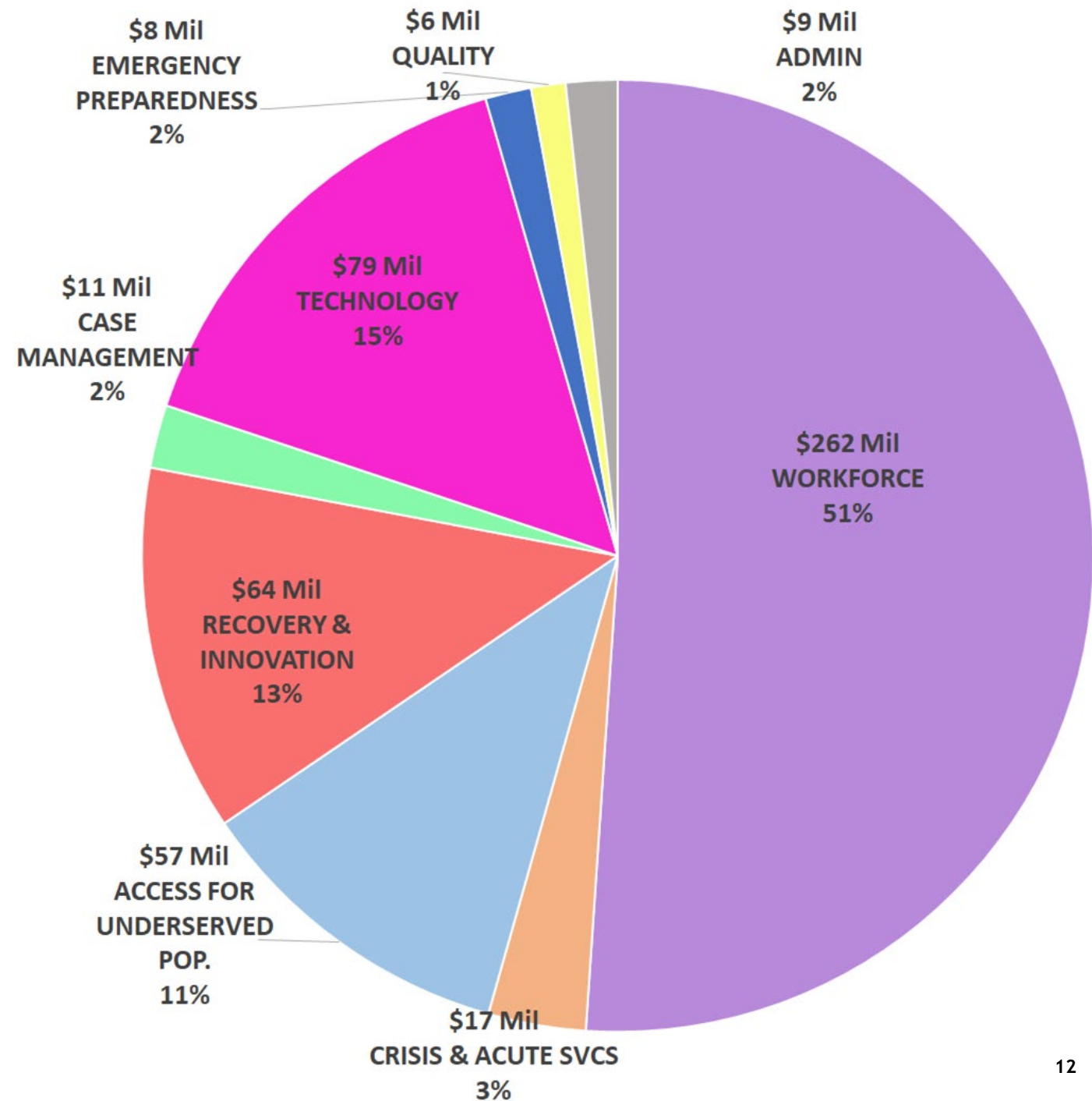

Rate Increases

Project Budget: \$244M

Initial Projects

Targeted Rate Increases

- 2.11% retroactive rate increase
- April 1, 2021 - March 31, 2022
- Upcoming Memo TODAY
- Enhanced Respite Rates

\$15/hr Direct Care Workforce Base Wage Initiative

- All Direct Care staff must receive a base wage of \$15/hr

STRENGTHEN THE WORKFORCE & ENHANCE RURAL SUSTAINABILITY

Standardize Training & Training Fund

Project Budgets: \$11M

Initial Projects

Standardized Training:

- Develop a standardized baseline curriculum that is competency-based and adult-learner centered for homemakers and personal care workers
- Use of this training would not be required but if used, would be transferable across employers
- Additional modules will be developed to assist workers in specializing and advancing
- The goal is to make the trainings free for workers and employers

Training Fund:

- Pool of funding that will be made available to individuals, employers or training providers through an application process

SUPPORT POST-COVID RECOVERY & HCBS INNOVATION

Community First Choice (CFC)

Project Budget: \$4M

Initial Projects

- Will make services available to an expanded population
- Includes mandatory services (Personal Care/Homemaker, IHSS/CDASS, Personal Emergency Response Systems, Member Training)
- States can choose additional services
- Increases access to Consumer-Directed Service Delivery Models
- Compliance with HCBS Settings Rule and CFCM is required prior to implementation

SUPPORT POST-COVID RECOVERY & HCBS INNOVATION

Tiered Alternative Care Facility (ACF) Rates

Project Budget: \$350K

Initial Projects

- Goal of the Tiered Rates is to create multiple levels for ACFs to limit placement into a skilled nursing facility and provide appropriate reimbursement based on the member's needs
- The Department will hire a contractor to develop a tiered rate methodology for setting levels, with an emphasis on secured settings, for the ACF benefit
- The contractor will analyze Colorado's assessment tool to determine a way to find the appropriate tier

SUPPORT POST-COVID RECOVERY & HCBS INNOVATION

Supported Employment Pilot Extension

Project Budget: \$1.2M

Initial Projects

This project will **extend and expand** the current Supported Employment Incentive Based Pilot Program to determine if expanding incentive based payments for Supported Employment services within the waivers is **cost effective** and produces **positive outcomes**.

This extension will include:

- Increased and expanded member participation
- Expanded provider participation
- Expanded regions being piloted beyond the Denver Metro corridor
- Additional data collection

STRENGTHEN CASE MANAGEMENT REDESIGN

Case Management Agency Training Program

Project Budget: \$525K

Initial Projects

- Develop a mandatory competency-based online interactive curriculum for case managers. Training will include fact sheets and desk aids for the case manager to assist with learning development and content retention.
- Training will focus on multiple elements including, but not limited to:
 - Assessment
 - Support Planning
 - Benefits and Services

Training design and development will begin in Spring 2022.

INVEST IN TOOLS & TECHNOLOGY

Eligibility Systems Improvements

Project Budget: \$1M

Initial Projects

- Bidirectional interface between CBMS and the CCM system
- Eliminate need for intermediary, PEAKPro
- Identify other enhancements to CBMS, CCM, & interChange
- Train case managers and eligibility workers
 - System changes
 - Eligibility requirements for HCBS, PACE, NF, ICF-IDD, HCA, & Medicaid Buy-In

Benefit: Improve the exchange of information between CMAs and the eligibility sites, improving efficiency and member experiences

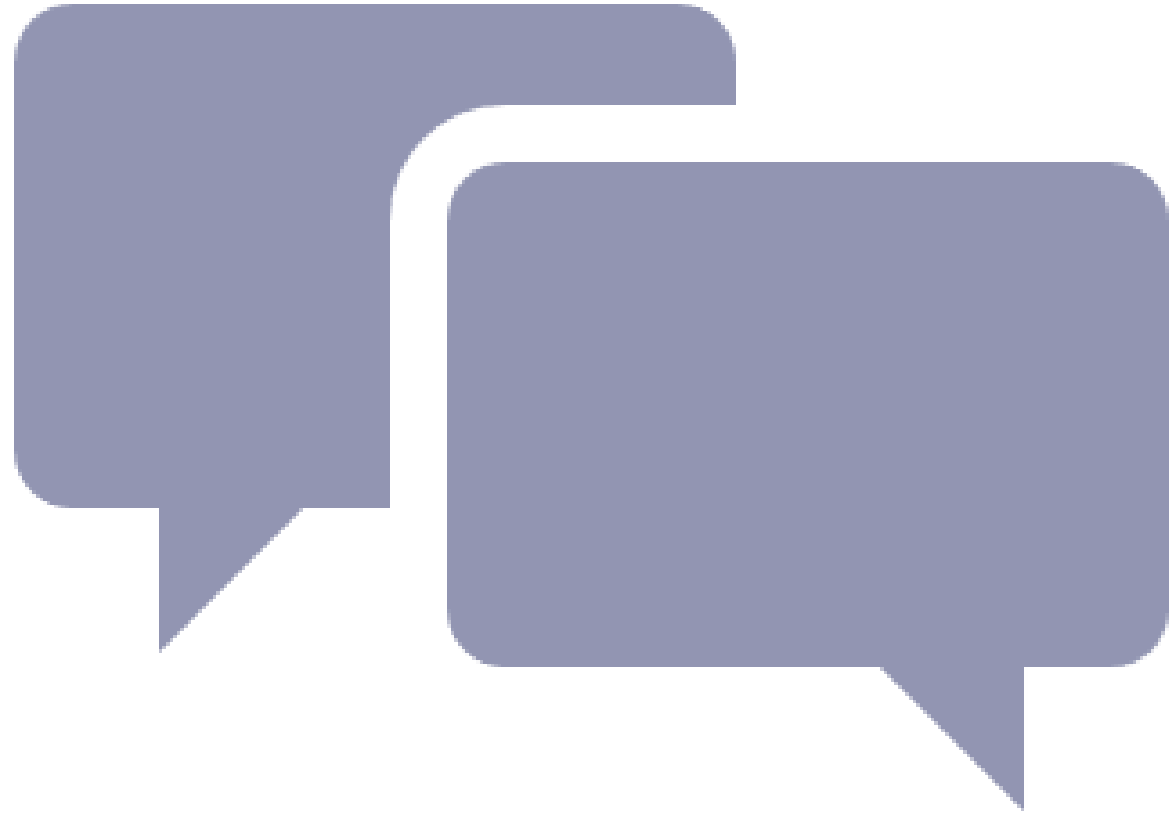
