




Rate Benchmark Comparison Outliers (Below 60% or Above 140%) SFY23 Emergency Medical Transportation


















Rate Benchmark Comparison Outliers (Below 60% or Above 140%) SFY23










# Rate Benchmark Comparison Outliers (Below 60% or Above 140%) SFY23

Outliers are defined as rates in CO that are under 60% or above 140% of the benchmark. The bubble chart below indicates that there are 2 procedure code/service variations with CO rates under 60% of the benchmark rate and 7 procedure code/service variations with CO rates over 140% of the benchmark rate for HCBS - service category.



There are 17 procedure code/service variations with no utilization data and rate-only comparison was applied to this analysis for HCBS - Respite Services service category. The scatter chart below indicates that there are 6 code/service variations with CO rates under 60% of the benchmark rate and 11 code/service variations with CO rates over 140% of the benchmark rate.





HCBS Respite Services Respite Care, Alternative Care Facility








