

Participant-Directed Programs Policy Collaborative March 2025 Attendance and Voting Rights

This document shows Participant-Directed Programs Policy Collaborative (PDPPC) voting rights as of March 2025. The ability to vote in the PDPPC is based on consistent stakeholder participation.
