Prenatal Plus Provider Toolkit

What is Prenatal Plus?

- Prenatal Plus (PN+) is a Health First Colorado (Colorado's Medicaid Program) funded program that provides enhanced, holistic care to Health First Colorado-eligible pregnant members who are at risk of having negative birth outcomes. The program provides eligible members with:
- A registered dietician: who can provide pregnant members with nutrition education and Supplemental Nutrition Program for Women, Infants, and Children (WIC) support.
- A mental health professional: who can address their psychosocial needs and increase resiliency.
- A care coordinator: to provide members with support throughout the pregnancy and advocate for services based on their individual needs.

Who is Eligible to receive services?

- Pregnant individuals who are participating in Health First Colorado.
- Individuals who are experiencing ANY of the high-risk factors according to our Intake Form

What sites/rendering providers can deliver services?

- Clinics
- Federally Qualified Health Centers
- Rural Health Centers
- Non-Physician Practitioner Groups
- Physicians
- Nurse Practitioners
- Certified Nurse-Midwives
- Physician's Assistants
- Obstetric offices
- Local Public Health Agencies
- Nonprofits serving mothers and families

How would we provide the services?

Model delivery can vary based on what already exists at your site. Some examples of delivery models include:

- Co-located obstetric and PN+ providers—PN+ care coordination team provides additional services at the time of an obstetric visit.
- Health department services that are provided when pregnant persons come in for WIC appointments.
- Special programs from local county services that offer home visiting from the PN+ team.
