1. Welcome, Introductions and Housekeeping

Voting Members Present: Bethany Pray (CCLP), Daphne McCabe (Boulder County Public Health), Bob Conkey (Health First Colorado member), Brent Pike (Health First Colorado Member), Samantha Fields (Health First Colorado member), Ealasha Vaughner (Health First Colorado member), Janelle Jenkins (Health First Colorado member), Jennie Munthali (CDPHE).

Voting Members Absent: Mike Morosits (Colorado Community Health Network), Fatima Kiass (Empowered Connections)

Daphne McCabe, PMME Co-Chair, opened the meeting by welcoming participants, reviewing housekeeping items, and confirming attendance. Voting members introduced themselves. The May meeting minutes were reviewed and approved.

2. ACC Phase III Change Management Updates (Andrea Bradley, HCPF)

Andrea Bradley, HCPF, provided an overview of the change management process for ACC Phase III. She highlighted the steps being taken to track issues and ensure smooth implementation. Committee members discussed how concerns raised by providers and members will be logged, monitored, and resolved. Questions centered on how communication will flow between HCPF, RAEs, and community partners during the transition.

Committee member comments included:

- A committee member asked how HCPF will track recurring provider concerns during the transition.

- Another member raised the importance of timely communication with community organizations.

- A member noted concern about the impact of staffing shortages on implementation.

3. Legislative Update (Jo Donlin, HCPF)

Jo Donlin, HCPF, shared updates from the most recent legislative session. She summarized key bills affecting Medicaid, behavioral health services, and care coordination. Committee members asked clarifying questions about funding changes and implementation timelines. Jo noted that HCPF is developing guidance to help stakeholders understand the impacts of the legislation.

Committee member comments included:

- One member asked whether new legislation would change eligibility rules for certain populations.
- A question was raised about how funding adjustments would be distributed across RAEs.
- Members expressed interest in receiving a written summary of the session highlights.

4. ACC Phase III Attribution (Matt Lanphier, HCPF)

Matt Lanphier, HCPF, reviewed the attribution process for ACC Phase III. He explained how members will be assigned to RAEs under the new structure and the methods used to ensure accuracy. Committee members discussed challenges related to continuity of care and member awareness. Suggestions were made to enhance outreach and ensure members understand their assignments and options.

Committee member comments included:

- A member asked how attribution changes will affect care coordination for highneed members.
- Another member raised concerns about members not understanding their new assignments.
- It was suggested that clearer outreach materials be developed for both members and providers.

5. Next Steps and Wrap Up (Daphne McCabe, PMME Co-Chair)

The meeting concluded with an open discussion facilitated by Daphne McCabe. Members reflected on the updates and next steps. No public comment was provided.

Committee member comments included:

- Members reflected on the importance of monitoring member experience during Phase III implementation.
- A suggestion was made to schedule a deeper dive session on attribution impacts in the fall.
