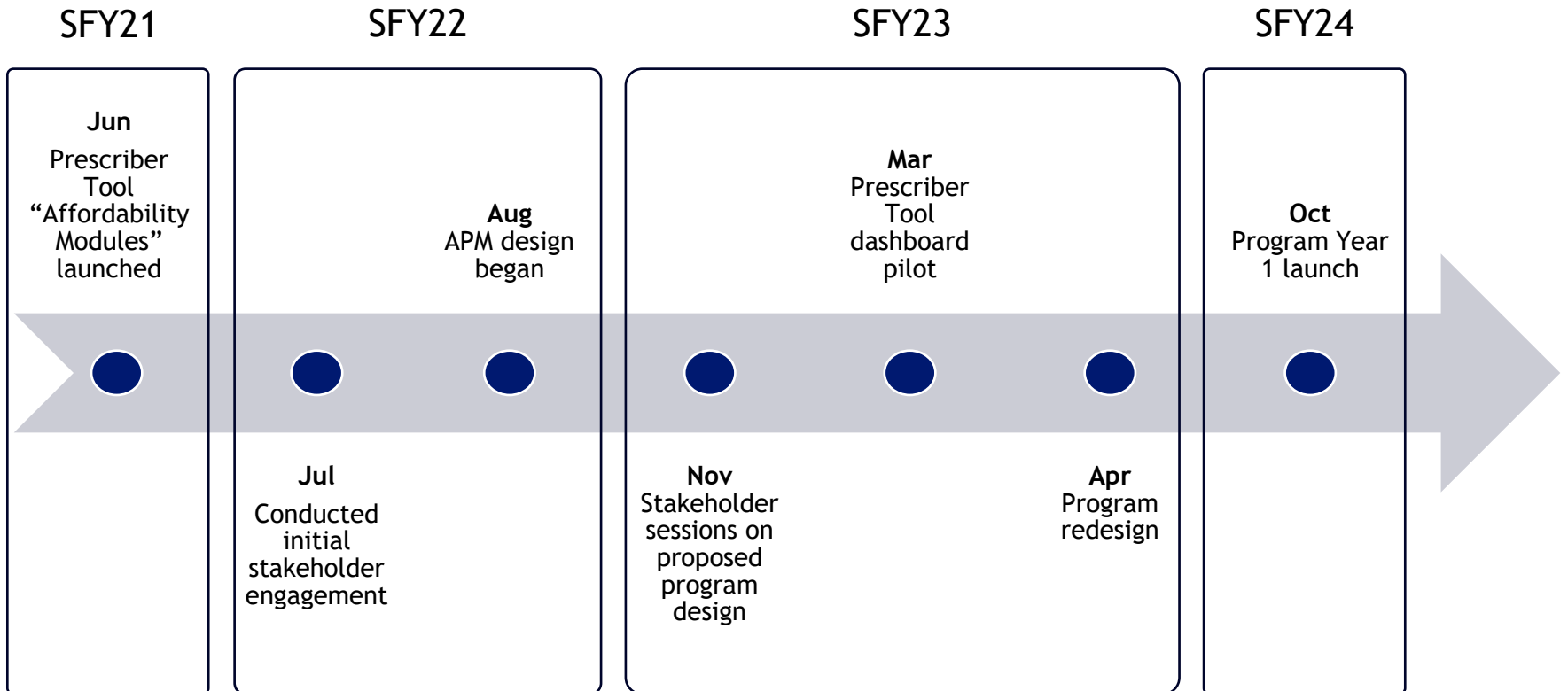


# Our Mission

Support accurate reporting of RTBI module function and use

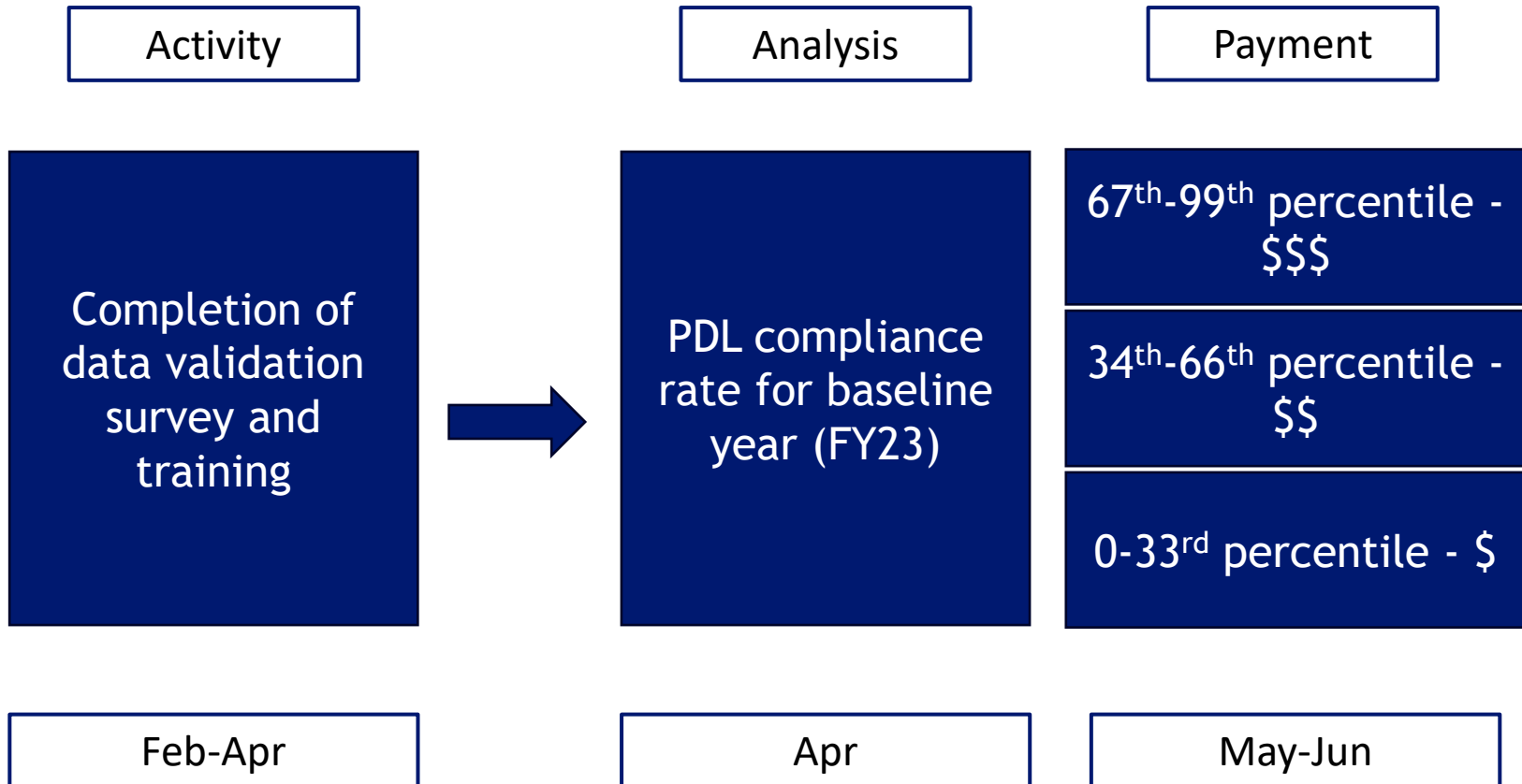

# Participation Eligibility

Eligible Practice Types	
04 - Dentist	26 - Osteopath
05 - Physician	32 - FQHC
06 - Podiatrist	35 - CMHC
07 - Optometrist	41 - Nurse practitioner
16 - Clinic practitioner	45 - Rural health clinic
22 - Nurse midwife	47 - Clinic - dental
24 - Non-physician practitioner - individual	61 - Indian Health Services - FQHC
25 - Non-physician practitioner - group	64 - Substance use disorder - clinics



# Design



# Shared Savings Payment

- Sharing 100% of savings generated from the Prescriber Tool in first year
- Based on comparison of PDL compliance shift pre-tool implementation and in baseline year
- Payments sent to eligible practices before the end of the state fiscal year (June 30, 2024)





# Dashboards

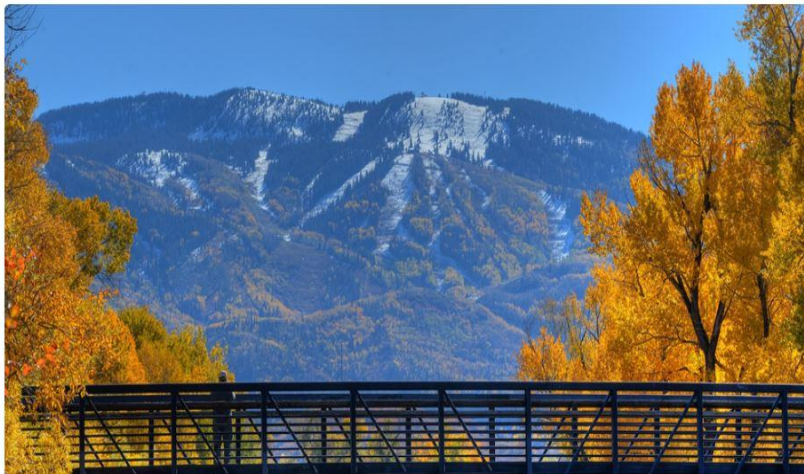
- Distributed per practice NPI
- Access point for the survey required for incentive payment eligibility
- Displays data for each of the four quarters of SFY23
- Facilitate communication and transparency with data that will eventually inform incentive payment
