Facility ID Now Included on Certain Home and Community-Based Services (HCBS) Provider ID Files

Some HCBS providers, based on provider specialty, require a Certification and Transmittal (C&T) with the Colorado Department of Public Health and Environment (CDPHE) and are issued Facility IDs as part of this process.

A field has been created for the Facility ID information to be recorded on provider enrollment files. These identifiers have been loaded onto existing provider records.

Providers newly enrolling into specialties for which CDPHE issues a Facility ID will be required to enter this information when submitting applications.

Health-Related Social Needs - Nutrition Benefit Stakeholder Webinars

Stakeholders are invited to participate in upcoming webinars to share feedback and ask questions about the development and implementation of the **Nutrition Benefit** under the Health-Related Social Needs (HRSN) initiative.

This benefit aims to improve health outcomes through targeted services, including:

- Nutrition counseling and education
- Medically tailored meals
- Pantry stocking or home-delivered meals

Stakeholder webinars will inform nutrition service delivery, billing, and policy design. The Nutrition Benefit will go live no sooner than January 1, 2026. The HRSN benefit rollout will occur in phases, beginning July 1, 2025, with housing.
