4. [House Bill \(HB\) 22-1289 Cover All Coloradans](#)

Cesar Zatarain, HCPF

- The Department has implemented the bill to expanding Health First Colorado benefits and Chip Plus benefits to pregnant people up to 12 months postpartum and then children that are age 18 and younger regardless of immigration status.
- Go Live date of January 1, 2025
- Same application on our Health First Colorado website to apply through the same process
- The Department is pushing out this information for those who are undocumented to apply now for EMS services, so they will already be in our system
- Toolkit and social media packet is in its final development stage
- Lactation expansion benefit: single user electronic pumps and multi-user pumps. As of today we have distributed over 9,000 single user electric pumps from Health First Colorado or WIC since 2022.
- Launching the restart of the Community Ambassadors Program, hopeful to bring in 13 sites, depending on the budget.
- Restarting stakeholder meetings at a monthly cadence-starting September 4th
- Late fall TBD date-host an enrollment webinar

Stakeholder Engagement

- Began in 2021, but the settlement was signed last February (2023).
- The Department has 5 years to create intensive home services for kids and families' model.
- Child and Family driven: User design (youth and families with lived-in experience will guide us on what is working and what is not. What they hope to see)
- Community Inclusive: Regularly engage with partners, advisory committees
- Services outlined in settlement: Intensive Behavioral Health Services. A continuum of mental health and support services or interventions
 - Intensive Care Coordination Services
 - Care planning, coordination and monitoring services and supports
 - Intensive-In-Home and Community Services
 - Mobile Crisis Intervention and Stabilization Services
 - Available 24 hours a day, 7 days a week
 - Standardized Assessment (including CANS) will be used to inform treatment decisions, the development of care plans, identify the specific needs of the family, and identify families that will benefit. Assessors include the Community Service Agencies (CSA), BHASO Independent Assessors, Crisis Stabilizations Units, Certified BH Provider.
 - The flow chart for care includes: Referral for a member to the RAE (screen for intensive needs, CANS), Intensive care coordination determined (in-home treatment, support services, behavioral health e-Consult, mobile stabilization)
 - ARPA investments:
 - \$5.1M for Behavioral Health Transitions Supports to increase workforce capacity to help children and youth transition from institutions back to the community
 - \$17M of microgrants for High Intensity Outpatients Treatment to increase capacity in the number of providers who can offer intensive treatment services to children and youth.
 - Discussion Questions:
