End of Year Update of the work for ACC Phase III, Katie Lonigro

- Total ACC Phase III engagements since November 2022
 - 105+ stakeholder discussions with 4,300+ attendees
 - 10 visits to P&CE
- Plan to release the DRAFT RFP by the end of January 2024
- <u>Concept Stage Summary</u> captures feedback from Aug. through October 2023
- Phase III RAE map decision

OCL/Capitation Alignment for ACC Phase III, John Laukkanen

Problem Statement:

- The Capitated Behavioral Health Benefit is a foundational array of coverage, intended to be available to all Medicaid members, including those on HCBS Waivers.
- Many HCBS Waiver members are denied BH services for co-occurring conditions due to diagnostic confusion and/or providers who are not confident or competent to treat members with these conditions.
- Many of these members with BH needs are regularly pushed to rely solely on the care they can receive through their HCBS Waivers, which do not contain the full array of BH services that the MCEs are responsible for providing.

Current Efforts HCPF is Taking

- Updates to MCE Contracts for July 1, 2023 that include:
 - Requirements for MCEs to use the DM-ID-2 (diagnostic tool for members with IDD)
 - Updates to Exhibit H- DEVELOPMENTAL DISABILITY AND TRAUMATIC BRAIN INJURY GUIDANCE
- HCPF is creating a UM Dashboard to track MCE authorizations/denials that will include diagnosis to help monitor trends related to care. - HCPF created a FAQ for members in Long-Term Care Settings, Regional Centers and for members on HCBS Waivers who many need to access RAE-covered BH Services
- OCL is working to draft policy guidance on payment (pathways for accessing/providing) for adaptive supports for members needing resources to help them engage in traditional behavioral health services.
- OCL will be creating a HCPF website as a single landing page for key resources for providers serving members with complex conditions and dual diagnosis.

BHA Efforts

- BHA Rules taking effect January 1, 2024:
 - A Comprehensive Provider must serve all priority populations (PP) [12.5.2.A.1] and have an Equity Plan that addresses this [12.5.4.A].
 - An Essential Provider is not required to have an Equity Plan related to serving priority populations.
 - A Comprehensive Provider [12.5.2.D.6] and an Essential Provider [12.4.3.D.6] "shall not refuse to treat an individual based on the individuals based on the individuals...Co-occurring mental health and substance use disorders, physical disability, or intellectual or developmental disability, irrespective of primary diagnosis, co-occurring conditions, or if an individual requires assistance with activities or daily living or instrumental activities of daily living...."
