eConsult Overview

- Colorado Medicaid eConsult is Live as of 2/1/24.
- eConsults provide asynchronous (store and forward) communications between a Primary Care Medical Provider (PCMP) and a Specialty Provider.
- Safety Net Connect (SNC) is the selected vendor for operating the State's eConsult Platform.
- Colorado Medicaid eConsult is a **free**, web-based platform. A **web browser** and **internet connection** are the only technology required to access the platform. No software installation is required.
- PCMPs can use multiple eConsult platforms (not tied to just one system/platform).
- Single Sign On (SSO) capability with most Electronic Health Records (EHRs).



Overview of First Annual Report Data

- Date Range: February 1st, 2024 - June 30th, 2024
 - Future reports will include a full SFY of data for a comprehensive analysis
- Focus Areas to Highlight:
 - PCMP Enrollment
 - Specialty Field Availability
 - Provider survey participation and experiences/feedback
 - eConsult Outcomes (PCMP management, Further work-up recommended, face-to-face recommended)
- RAE 1, has established its own eConsult program for all eligible Members in its region

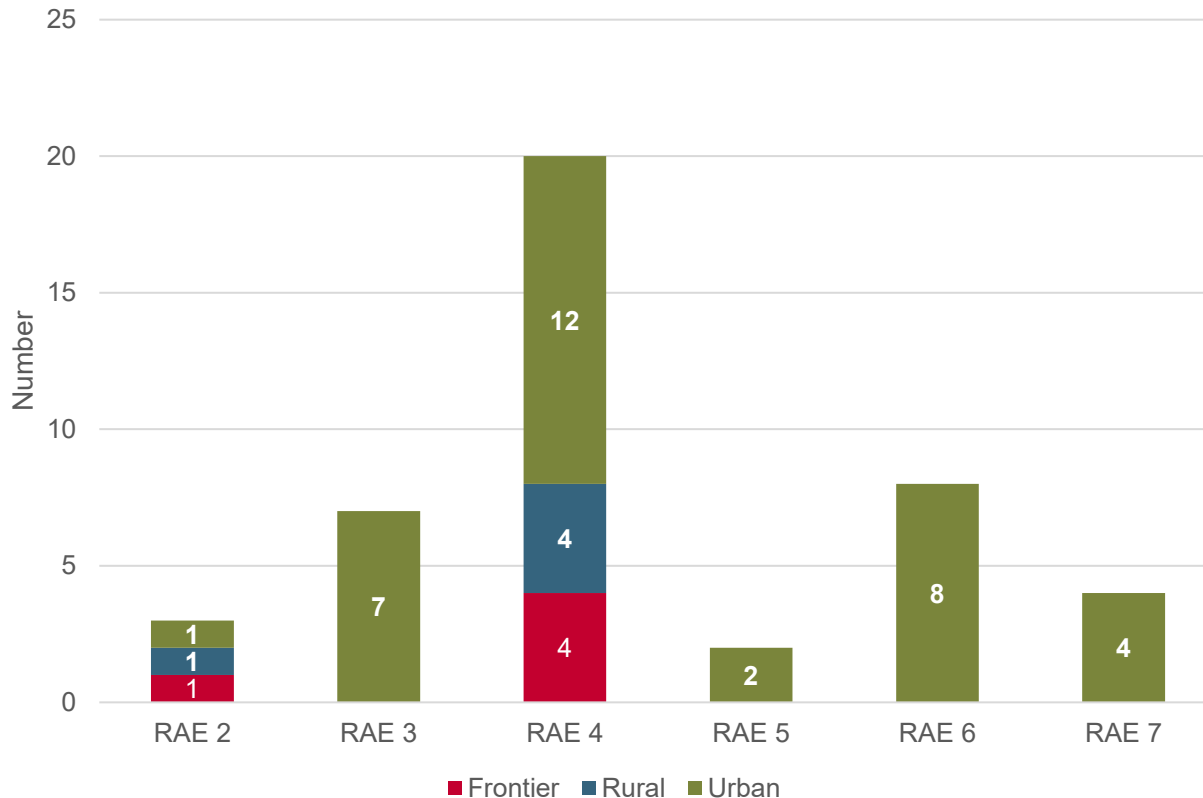

In SFY 23-24, 44 PCMP sites have been trained with a total of 135 trained Providers.

Participating PCMP Sites By RAE By County Designation

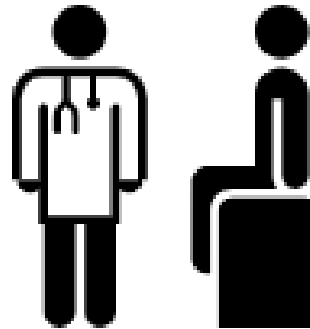


Provider Experience - PCMPs

Quicker consults that don't necessarily need an in-person visit or at least some guidance while we are waiting for patient to be seen

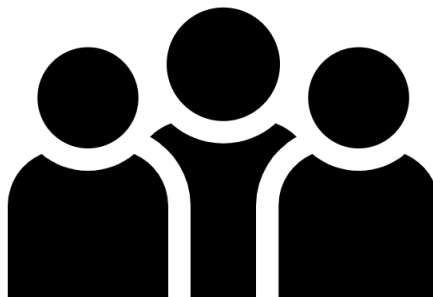
Treatment plans improved

Allowed assistance for PCPs to help patients with issues when specialist in my field hard to come by

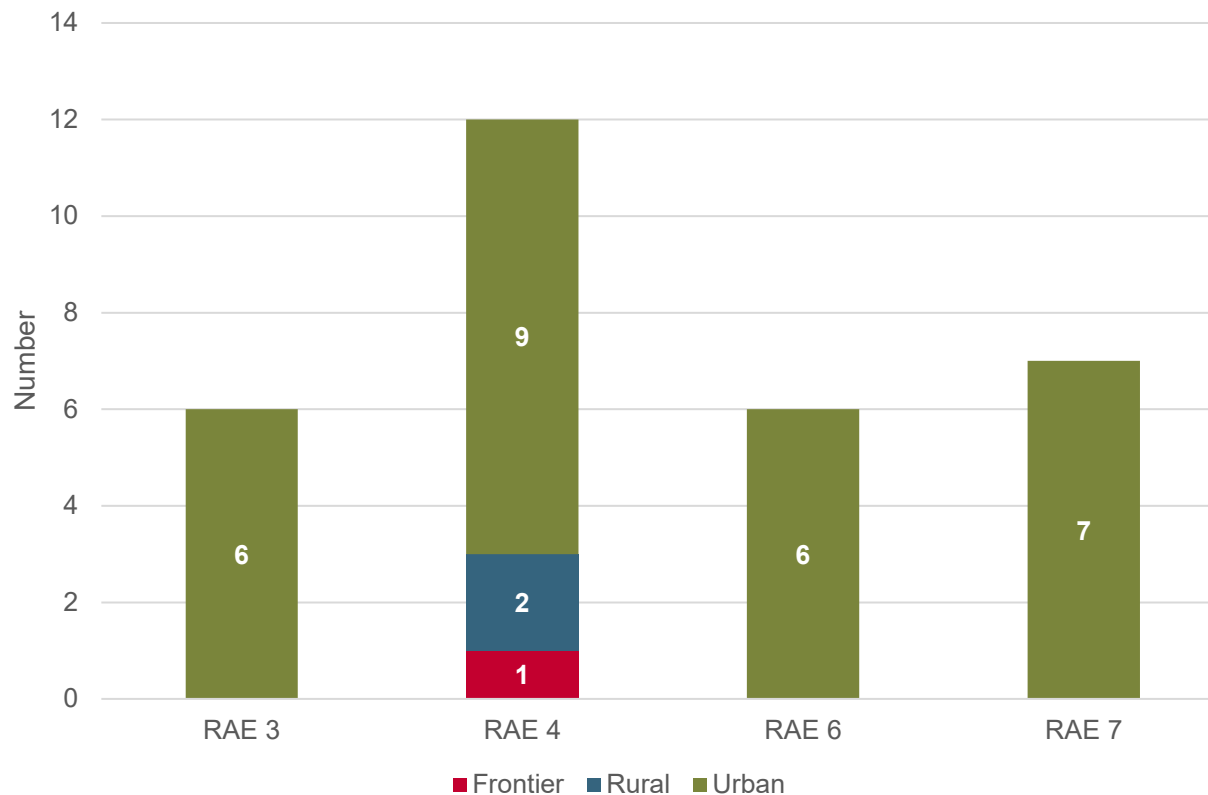


As a specialist, this can be very helpful when the patient ultimately comes into the clinic

SFY 23-24 Submitted eConsults

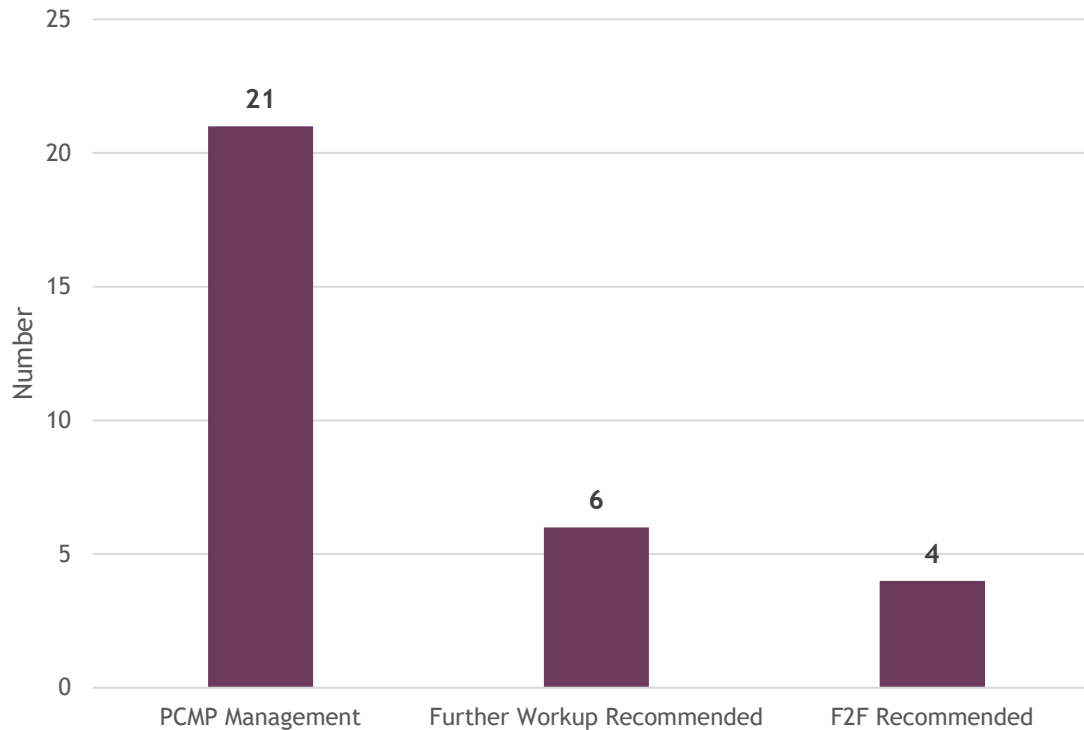
In SFY 23-24, RAEs 3, 4, 6 and 7 submitted a total of 31 eConsults through Colorado Medicaid eConsult.



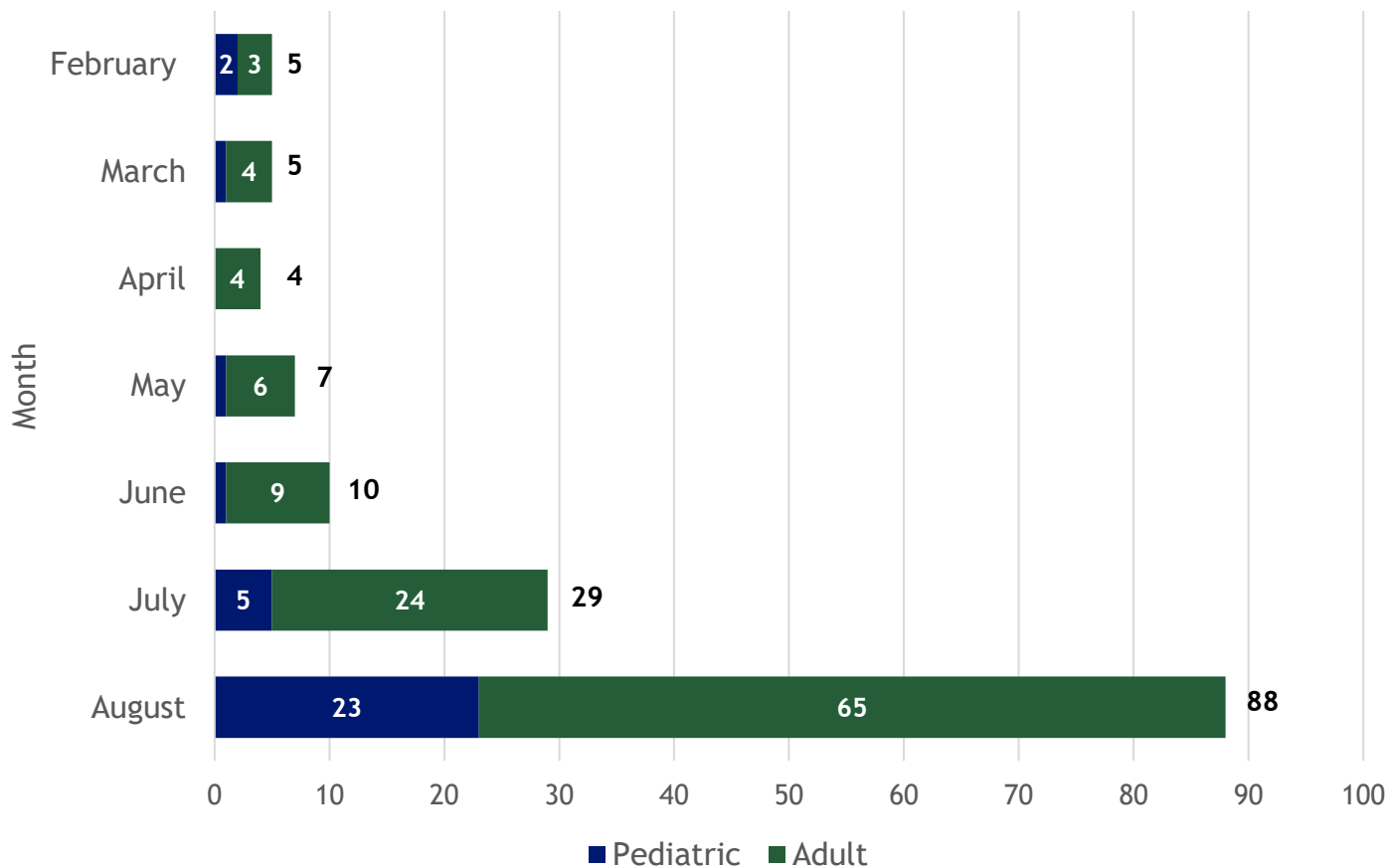
eConsult Outcomes

In SFY 23-24:

- 21 eConsults were resolved as “PCMP Management”
- 6 were closed as “Further Workup Recommended”
- 4 were resolved as “Face to Face Recommended”

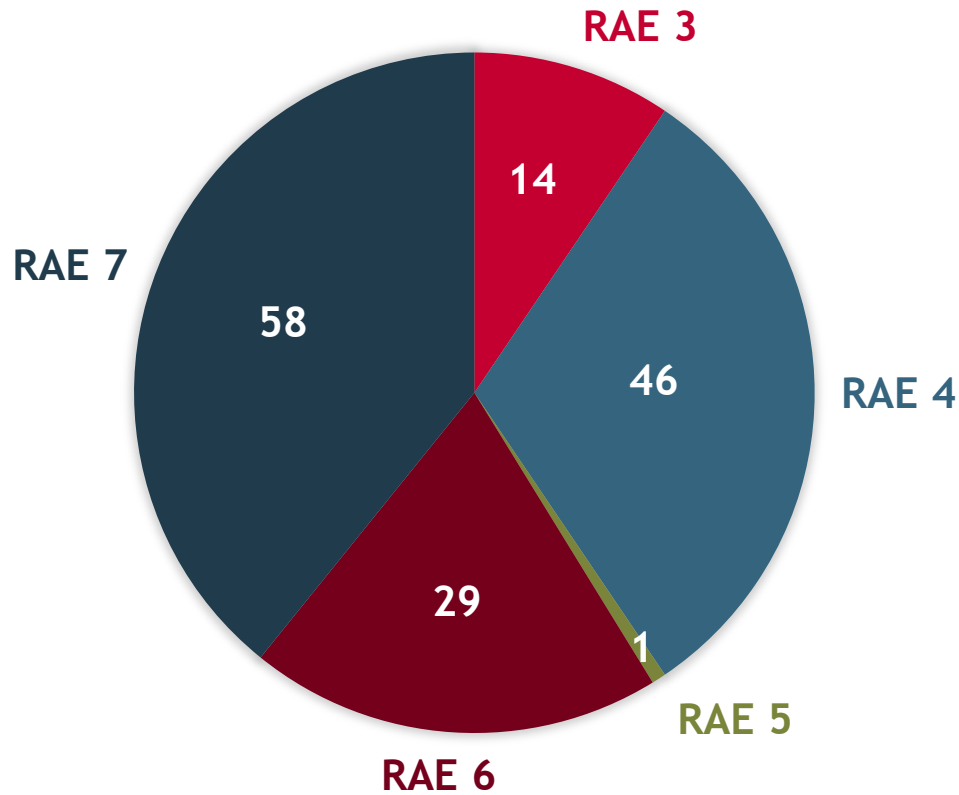


eConsult Submissions to Date by Month



eConsult Submissions to Date By RAE

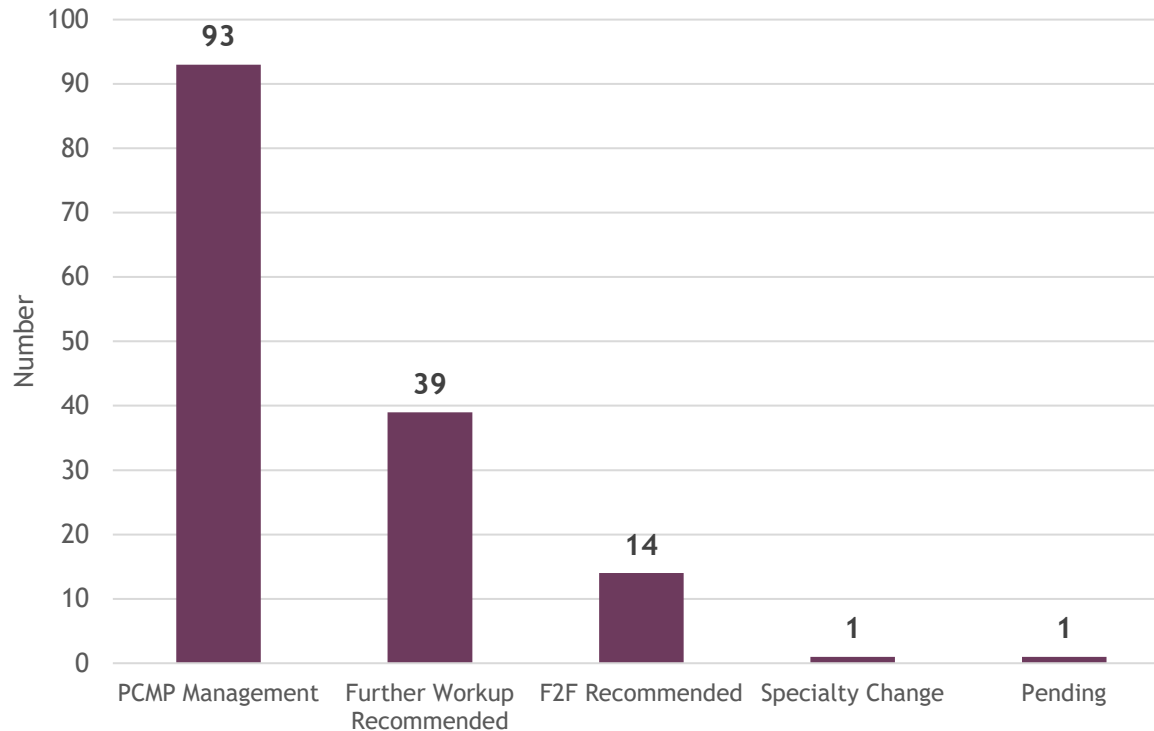
As of August 31, 2024, a total of 148 eConsults were submitted.



eConsult Outcomes to Date

As of August 2024:

- 93 eConsults were resolved as “PCMP Management”
- 39 were closed as “Further Workup Recommended”
- 14 were resolved as “Face to Face Recommended”
- 1 was closed as “Specialty Change”
- 1 is pending for close code



PCMP Enrollment to Date

PCMP Enrollment: 2/1/24 to 8/31/24

Enrolled and Trained PCMP Practice Sites and Providers

Total Trained Practice Sites	100 Practice Sites
Total enrolled and trained Providers	255 Providers



Upcoming Policy Update

- Expansion of the Submitter Role
- Specialty to Specialty eConsults
 - Current PCMP user role will be expanded to a more generalized submitter role, this will allow flexibility for non-PCMPs (e.g., Specialists) to submit eConsults
- HCPF will present the Specialty to Specialty Policy update more in-depth at upcoming stakeholder engagement meetings
