Colorado Rural Health Transformation Program Process

Communication Purpose

This communication is intended to answer questions on the process being undertaken to: (a) complete and submit the Rural Health Transformation Program (RHTP) application to the federal government for funding, and (b) manage the dissemination of federally awarded grant dollars. It is also intended to clarify that a Rural Health Transformation Advisory Committee will be established, when, and for what purpose.

RHTP Application Completion & Submission

Clearly, this federal grant opportunity is very important to many rural providers, their associations and representatives, as well as other stakeholders. This RHTP Application Completion & Submission process is intended to ensure flexible and targeted stakeholder engagement that allows the Department of Health Care Policy & Financing (HCPF) to reach a broad array of voices who want to be heard, and to be responsive to those voices, while operating agilely, with fewer bottlenecks and transparency. It further enables the state to meet the application completion and submission deadline of early November, as currently targeted by CMS. CMS is indicating that notice of grant awards will be public by December 31, 2025.

Stakeholder Engagement

Initial stakeholder engagement began in August 2025. The application was released by CMS on September 15, 2025. HCPF will continue to work with stakeholders to create and aggregate the application content through an Application Core Working Group and additional stakeholder meetings and opportunities for input and feedback.

Following Colorado's RHTP application submission to CMS, HCPF will convene a formal RHTP Advisory Committee to:

- Develop requests for applications for grantees
- Recommend potential grant programs
- Support ongoing program administration, such as grantee monitoring, federal reporting, and award revisions
