# 2023 RHC Rates

- 2023 RHC rates will be effective January 1, 2023
- Hospital Based RHCs - no change to rate setting
- Freestanding RHCs - use updated UPL rates (\$126.00)

- Data Section and Attestation Statements for January - March 2022 were due March 31, 2023
- Next reports for April - June 2022 due June 30, 2023
- HCPF will process data received and send out reconciliation requests

  - HCPF staffing shortage impacting timelines
