We used a hybrid format at our April stakeholders meeting. Attendees were able to meet remotely or in person, depending on their preference and level of comfort. Overall, we received very good feedback on this format and plan to use this flexible style for future stakeholder meetings. It was good to see some faces in person as we are navigating this new normal.

Guests from the Department shared upcoming Health First Colorado enrollment changes as well as potential member impact.

Stakeholders provided feedback about the format of annual training going forward now that some pandemic restrictions are being lifted. While we agreed that in-person training is ideal, we will need to remain flexible as COVID-19 cases and restrictions continue to fluctuate. For that reason, we will continue to offer a virtual option. Please look for additional training details in the coming weeks.

The new School Psychologist qualifications were discussed along with potential Random Moment Time Study impacts starting in the October - December 2022 quarter. Those qualifications are as follows:

Shall possess a Master Certificate License from the Colorado Department of Education as a special services provider with an endorsement in school psychology with either an NCSP certification OR PRAXIS 5402 (147). Services of licensed School Psychologists must be within their scope of practice according to state law. (Effective Oct. 1, 2022)

Thanks to everyone for keeping that line of communication open with your stakeholders. Your continued feedback helps improve the program as well as the support we can provide.

#### Spread the word: Member Contact Information Update

Please help us spread the word to Health First Colorado (Colorado's Medicaid program) and Child Health Plan *Plus* (CHP+) members to update their contact information. During the public health emergency (PHE), members stay enrolled in health coverage even if they have household or income changes. At the end of the PHE, many Health First Colorado and CHP+ members will receive a packet to renew their coverage. Members who fail to fill out necessary information may lose their benefits.

We know that many members have moved over the past few years. It is crucial that we have correct addresses so that members get the information they need to keep or change their coverage. We collaborated with community partners to create an Update Your Address campaign for members. Please use the following resources to spread the word.

# **Program Components**

### School Based Psychologists - Potential RMTS impacts

As stated in the Department Updates and in previous Department email communications, the supervision requirement for School Psychologists will be lifted as of Oct. 1, 2022. As of right now, the potential implications of school-based psychologists on the RMTS program are expected to produce a positive effect on the Direct Medical Percentage. Coordinators can expect more allowable providers regarding Staff Pool List (SPL) additions. All additions are subject to licensure reviews to determine eligibility in the RMTS program.

#### Free Care Reimbursement

The FY 2020-21 was the first year that Free Care was included in annual reimbursement. For the fifty-seven (57) districts that participated last year, Free Care resulted in a total of \$2.7 million additional in district reimbursement. As a reminder, because Free Care was implemented on Oct. 1, 2020, only 75% of reported direct medical costs were included in the Free Care calculation. The FY 2021-22 annual cost report and cost settlement will include 100% of reported direct medical costs in the Free Care calculation.

### Preparing for October - December 2022 (OD22)

Since there is no time study in the July - September 2022 (JS22) quarter, coordinators are expected to get ready for the OD22 quarter, which will open in August. Working closely with the district human resource department is key to figuring out who should be included on the Staff Pool List (SPL). Larger changes are expected to be made to the SPL at the end of the school year due to staffing changes.

Keep the following in mind:

- Confirm that providers on the SPL are not 100% federally funded.
- All direct service cost pool providers should have the correct qualifications and licensure. School districts must ensure licensure is updated and on hand in case of review!
- Look for the 'RMTS At-A-Glance' document in August. This document can be sent
  to providers on the SPL to help them understand the RMTS program and once sent,
  helps coordinators identify undeliverable emails that require revision or removal
  from the SPL.
- Calendars for OD22 should have Thanksgiving and winter break marked as 'Holiday/Non-Workday' in the PCG Claiming System.

### Justifying End of School Year Moments

Active moments that are unanswered at the end of the school year can be justified by coordinators by using the 'No Work' option in the PCG Claiming System if the provider has left for the summer break. The leave should be appropriately marked as **paid/unpaid**. These moments will not be included in the district/BOCES compliance calculation; therefore, they do not count against response return rates.

To justify end of the school year moments:

- 1. In the PCG Claiming System, from the green action bar, select 'All' from moments option
- 2. Locate the providers who were assigned moments after the start of their summer break and who will not be able to respond
- 3. Click the dropdown arrow to the right of the provider's name (see below)
- 4. After selecting 'No Work,' answer the paid/unpaid question to justify the moment appropriately.
