### **Discussion: Audience feedback**

#### **RAE 3 Challenges and Opportunities**

- Growing need for transportation to access treatment and services.
  - Patients may consider using IntelliRide/NEMT (Non-Emergent Medical Transportation). More information available on Department's web page, at:

- Need: more services for pregnant/parenting women

### **Capacity Mapping Feedback**

- Mapped data may not be accurate because some facilities may be licensed for 3.1, 3.5, 3.7 but are not providing any 3.7 services because their beds are filled up with 3.1 and/or 3.5 clients
- Consider looking at both overall/total bed counts vs. Medicaid-specific bed counts
- Consider reviewing/incorporating Colorado Department of Public Health and Environment (CDPHE)'s workforce mapping efforts into HCPF capacity assessment.

### **Audience Concerns/Recommendations for New Benefit**

- Important to not reduce reimbursement rates in high-capacity areas;
- Ensure adequacy of treatment across the continuum; need to verify and ensure the networks of treatment can handle the increased volume
- Make sure outpatient and IOP reimbursement are adequate, to avoid clients being pushed into residential/Inpatient treatment levels
- It is critical to make sure that residential referrals are appropriate and not seen as the only treatment option for everyone; this will result in better treatment outcomes as well as cost containment.
- Provide training for providers on how to bill Medicaid and what services can be billed for.
- Consider creating a how-to guide for providers on billing/coding the new services soon so providers can begin training their staff.
