Policy

U.S. Citizenship/Identity Verification Policy

- All Medicaid and CHP+ clients who are **U.S. citizens** must have citizenship and identity verified
 - Federal Deficit Reduction Act of 2005 (DRA) and Children's Health Insurance Program Reauthorization Act of 2009 (CHIPRA)
- Medicaid citizenship and identity rules effective July 01, 2006
- CHP+ citizenship and identity rules effective January 01, 2010

U.S. Citizenship/Identity Verification Policy

- Medicaid regulations
 - 10 CCR 2505-10, Section 8.100.3.H.
- CHP+ regulations
 - 10 CCR 2505-3 Section 130.1.B.
- Exempted:
 - Presumptive Eligibility clients
 - Newborns of mothers receiving Medicaid or CHP+
 - Clients currently eligible for SSI, SSDI or Medicare
 - Foster care children

Interface Policy

- SSA real-time interface now available to verify U.S. citizenship and identity information
 - Positive match verifies both U.S. citizenship and identity
 - Interface used before requiring documents from applicants
 - Applicants who do not match with interface will be given the opportunity to provide original documents
 - Reduces administrative burden on clients, application sites and eligibility sites
- Authorized by P.L.111-3-CHIPRA of 2009

 - Selection Criteria for request file
 - Processing Schedule for request and response files
 - Response Records
 - Verification Codes
 - Alerts
 - *View SVES SCHIP Citizenship Verification Data*

Selection Criteria

- Selection Criteria for request file
 - Medical Program (LTC, AM, FM, CHP+) application date of 1/1/2010 or later
 - Part of an Active LTC, AM, FM, CHP+ case (Open or Pending case status)
 - Valid SSN (All Numeric and should not contain the same digit (777-77-7777))
 - First Name and Last Name Populated (No Spaces)
 - Valid date of birth
 - Valid Gender (Male, Female or Unknown)

Selection Criteria

- Selection Criteria for request file Cont...
 - Individual should be a U.S. Citizen, *US Citizen* Field = **Y**
 - *Citizenship Acceptable Document* Field = **N** or Blank
 - *Citizenship Verification* Field \neq **Received** or
 - *Citizenship Verification* Field = **Received** and *Source* Field = **Client Statement**
 - *Citizenship DRA Met* field = No

Processing Schedule

- Processing Schedule for Request and Response Files
 - The SCHIP-I Citizenship Verification Process occurs as follows:
 - **Request file** is transmitted daily from CBMS to SSA, every half hour on the quarter hour
 - **Response** file is transmitted immediately from SSA to CBMS
 - **Verification Code records** are processed immediately

Response Records

- A response record will be received for each client sent in the request file and will include a code
 - Verification Codes
- Response Record will be located in the ***View SCHIP Citizenship Verification Data*** page
- Response record will remain on page for 60 months unless an updated record is received

Verification Codes

- Verification Code will be included within the response record located in the ***View SCHIP Citizenship Verification Data*** page
 - Verified SSN Verification Codes
 - Unverified SSN Verification Codes

Verified SSN Verification Codes

- SSN has been verified
 - **A** = Citizenship and Identity are confirmed
 - **B** = Citizenship and Identity are not confirmed
 - **C** = Citizenship and Identity are confirmed and there is an indicator of death
 - **D** = Citizenship and Identity are not confirmed and there is an indicator of death

Unverified SSN Verification Codes

- SSN has not been verified
 - **1** or **M** = SSN not in file
 - **3** or **P** = Surname matches but DOB does not match
 - **5** or **R** or **F** = Surname or given name does not match
 - ***** = Input SSN not verified
 - If one of the codes above is received and there is an update made to the client's demographics (First or last name, DOB, SSN, Gender), the client will be included within the next request file

Verification Checklist

- If the client meets the selection criteria, they should not be asked to provide these documents unless we are unable to confirm this information with SSA
- Missing verifications will be suppressed from the VCL if SSA was able to provide confirmation
