Health First Colorado covers both manual and electric breast pumps. Pregnant members may receive a pump as early as the 28th week of pregnancy. Postpartum members may receive a pump at any time. Breast pumps may be prescribed by a physician, physician assistant, nurse practitioner, or certified nurse midwife.
