1.010 FINANCE AND ACCOUNTING: The following subsections have been adopted with the amendments indicated based on the Executive Director's review of the rule and consideration of public written comment and public testimony.

• 1.010.1 The "Business Process Standards" definition was adopted with the amendments indicated to clarify the County Department's role and to remove language around best practices.

- 1.020.3.6.a.vi The phrase "joint analysis" was amended to "joint data review" by the Executive Director.
- 1.020.3.6.c.ii This subsection on identifying opportunities to improve efficiencies was added by the Executive Director in response to public comments after the Executive Director declined to adopt the rule on unavailability of funding, as noted below.
- 1.020.3.6.c.iii This subsection on soliciting input and feedback on strategies from County Departments was added by the Executive Director in response to public comments after the Executive Director declined to adopt the rule on unavailability of funding, as noted below.
- 1.020.3.6.d This subsection concerning term-limited waivers for County Departments was amended by the Executive Director to clarify language after the Executive Director declined to adopt the notification requirements, as noted below.

New Permanent Rules - Rejected

- 1.020.3.6.b.i The July 1, 2027 start date for Business Process Standards was rejected by the Executive Director
