# Six Major Contract Tasks

## 1. Environmental Scan

- **Key question:** What kind of oversight do host homes have in other states?
- **Task:** Review and compare oversight regulations of host home like settings in other states
  - Compare on issues such as licensure/certification; environmental safety requirements; incident reporting; training; background checks and exclusion rules; participant rights; grievance processes
  - Examine the relative roles of the state oversight agency, case management agency and host home providers.
- Draft Due: December 6, 2023

#### 2: Review of Host Home Data as Available

- **Key question:** What problems have been documented with host home providers?
- Task: Review data available from
  - > CDPHE recertification inspections for PASAs with host homes
  - > CDPHE complaint responses against host home providers
  - > Incident reports associated with host home providers
- Assess most common reported issues and all severe issues
- **Draft memo due:** 6 weeks after receipt of data

## 3: Support for Stakeholder Group Process

- **Key question:** Are there special topics the stakeholder group would like more information on?
- **Task:** Prepare up to 3 short (1-3 page) memos or brief presentations to frame discussion on specific topics as selected by the Department.
- Assist with agenda development, note taking and minutes
- **Draft Discussion Memos or Presentations:** due one week ahead of meetings

## 4: Focus Groups

- **Key question:** Are there issues specific to different constituents that may not be fully captured in the larger stakeholder group?
- Task: Conduct separate focus groups (timing TBD) with:
  - Individuals/families with lived experience
  - Host home providers
  - Host home agencies
  - CCB case manager representatives
  - Advocacy groups
- Draft summary of themes: due 3 weeks after each group

## 5: Grievance Procedures Infographic and Resource Packet

- **Key question**: How can individuals, case managers, and host home providers better understand and use new grievance procedures?
- **Task:** Develop a set of plain language support materials to reflect the new (December 2023) host home agency grievance procedure regulations.
  - Establish a common flow and set of procedures across all host home agencies.
- Draft packet due: March 31, 2024

## 6: Consensus report

- **Key question:** How will the stakeholder workgroup's work translate into recommendations for better oversight?
- **Task:** Develop a summary report of recommendations from HCPF and stakeholder workgroup for additional oversight measures or procedures, proposed regulations or waiver changes.
  - Incorporate as appropriate findings from the environmental scan, data analysis, and focus groups
- This report will be shared with the Host Home workgroup for review and feedback.
- **Draft Report due:** April 30, 2024; Final incorporating comments and recommendations due June 30, 2024
