



## Health First Colorado (Colorado's Medicaid Program) RAE Tip Sheet for Justice System Partners

Regional Accountable Entities (RAE) provide support for individuals who are enrolled in Health First Colorado (Colorado's Medicaid Program) and need connection to medical and non-medical resources.

## RAEs can help members:

- Understand covered benefits/services and find their way around the health care system
- ✓ Find providers for medical, behavioral health, dental and vision needs
- ✓ Learn how to complete and submit certain types of paperwork or applications
- Get answers to questions about health/wellness and learn about options
- ✓ Locate resources to help with needs such as food, housing, and transportation for health care appointments
- Connect with a RAE care coordinator for extra support with their health needs

Beginning July 1, 2025 there will be four Medicaid regions. A RAE is assigned based on the location of a Medicaid member's primary care medical provider (PCMP). If the member does not have a relationship with a PCMP, their county of residence determines RAE assignment. The table below lists the RAE for each region, counties served and contact information.
