








CMHCs provide mental health treatment services to all Coloradans, including Health First Colorado (Colorado's Medicaid program) members and uninsured Coloradans. There are currently 18 CMHCs in Colorado.

Description of Cost Report Schedules

The table below details information required in each schedule, or sub-list, of the CMHC cost report. Additional detail is available in the CMHC Cost Report Explanation and CMHC Cost Report Walkthrough fact sheets. Cost report data informs future rate setting for CMHC providers.

1: Expenses	Details expenses.
1A: Non-Clinical Direct Salary Limit	Identifies the five largest non-clinical direct
Limit	salaries paid during the cost reporting period.
	Direct salary includes wages and bonus amounts.
1B: Indirect Cost Allocation	Details the methods used to allocate indirect
Methodology	costs amongst all functional cost centers on

1C: Related Party Transactions	Identifies all transactions with related party
	entities.
2: Service Groups	Accumulates amounts from the subsequent
	series of schedules, in order to summarize costs
	by applicable service group.
2A: Emergency Services	Identifies costs associated with emergency
	services provided. These services are those that
	are necessary to stabilize individuals
2B: Consultative and Educational	experiencing a behavioral health emergency. Identifies costs associated with consultative and
Services	educational services provided. These services
	include all non-clinical services that enhance
	care coordination and the health and well-being
	of individuals.
2C: Outpatient Services	Identifies costs associated with outpatient
	services provided. These types of services focus
	on maintaining and improving functional
	abilities for a patient at risk of, or with a
	history of, psychiatric hospitalization.
2D: Partial Hospitalization	Identifies costs associated with partial
	hospitalization services.
3: Inpatient and Residential	Identifies costs associated with residential and
Services	inpatient facilities reported in Schedule 1
	Column 4, All Inpatient Hospital Services and
A Deep Heit Cent Celeviet:	Residential Services without RVU Weights.
4: Base Unit Cost Calculation	Calculates the provider-specific base unit cost.
